## **MEMORANDUM**

**SUBJECT:** 2023-24 Adult High School Co-Enrollment Program Eligible Course List

School districts and Florida College System (FCS) institutions are permitted to allow students currently enrolled in high school to co-enroll in their adult high school program under certain conditions specified in [Section \(s.\) 1011.80\(10\), Florida Statutes \(F.S.\)](#). Students in grades 9-12 may be reported in this program under the following circumstances:

- Eligible students may not have a pattern of excessive absenteeism or habitual truancy or a history of disruptive behavior;
- Enrollment is limited to the core curricula courses for credit recovery or dropout prevention; and
- Eligible students may enroll in up to two courses per year (please note that this is based on course numbers, not high school credits).

If a district or FCS institution does not operate an adult high school program (program number 9900010), then they are not eligible to offer the co-enrollment program.

Districts and colleges may not use any federal grant funds from the Adult Education and Family Literacy Act (Title II, Workforce Innovation and Opportunity Act) to support a co-enrollment program. Title II funds may only be used for adult education programs that serve students who are not enrolled in K-12.

As required in s. 1011.80(10), F.S., the Department of Education has developed a list of courses to be designated as core curricula courses for the purpose of co-enrollment. Please use the attached list when determining what courses are allowable for co-enrolled students. The list can also be found on the [2023-2024 Adult Education Curriculum Frameworks \(fldoe.org\)](#) under the "Adult High School" heading.
