6H-1.017 Area Served. Approval to operate a community college constitutes approval to offer courses within the community college district. The college shall not offer courses outside its district except in unusual cases when approved by the State Board of Community Colleges; except the college may offer courses in Florida outside its district in unusual cases when approved by the president of the community college within the district where the courses are offered and the enrollment is not counted for funding purposes or to meet enrollment assignments.
