<p>Board-approved funding for school-wide interventions- The district realigns its financial resources to provide targeted funding to meet the needs of “F” schools in several ways. The cNET Team, which includes a principal and dedicated coaches, receives a board-approved budget dedicated to providing services to “F” and “D” schools. <p>Extended learning program with transportation – Extended Learning Opportunities (ELO) are provided for low performing students throughout the school year. The school receives additional SAI dollars for this purpose based upon the number of low-performing students at the school. Tutoring programs are aligned to meet the differentiated needs of students. The school analyzes assessment data for correctly placing students in tutoring programs that will support each student’s area of deficit. The tutoring program is deigned to meet the specific needs of the students at the school in order to provide differentiated instruction. Programs are provided before and after school and on Saturdays and employ proven, research-based practices.</p> <p>The school has access to Title I, SAI and 21st Century Grant funds for extended learning. Transportation is provided through the 21st Century Grant.</p>	<p>Begin within the first quarter and continue ongoing</p>	<p>Ramon Dawkins, Principal (754-322-8550)</p>	<p>Data is analyzed for all students participating in ELO at the monthly cNET meetings. <p>School-wide staff development- Prescribed staff development will be provided based on FCAT data, discipline data, classroom walk-throughs and formative assessments. cNET staff will deliver staff development in collaboration with school staff. Human Resource Development (HRD) publishes a year-long menu of in-person and online staff development, which reflects analysis of needs reported on teachers' PGP's. Teachers at the school will be encouraged to attend specific workshops aligned to teacher needs.
