Line = 1 Full-Time\First-Time Degree\Certificate Seeking and Gender not equal to 'X' (unknown gender is not reported to IPEDS)

Deceased Exclusions

Include all deceased exclusions from Fall 2015-16 through, and including, Summer 2018-19.

Return the Deceased Exclusions file to CCTCMIS, via TIBCO, with the student identification number of the deceased students, if any, using the following file naming convention:

CCxx.STU.EXCLUDE2.T2B2016.PROD.txt (where xx is the institution number)

NOTE: Files with invalid filenames will be rejected by the server and deleted.

Deceased Exclusions files are due by Friday, November 16, 2018 and the completed certification form is due by Monday, November 19, 2018.

Include **ONLY** those records of students in the cohort who are deceased. If your college has no deceased students in the cohort, please send the certification form only and indicate "No" on the form.

Records not in the original cohort will not be loaded.
