Line = 1 Full-Time\First-Time Degree\Certificate Seeking and Gender not equal to 'X' (Unknown gender is not reported to IPEDS)

Deceased Exclusions

Include all deceased exclusions from Fall 2012-13 through, and including, Summer 2018-19.

Return the Deceased Exclusions file to CCTCMIS, via TIBCO, with the student identification number of the deceased students, if any, using the file naming convention below:

CCxx.STU.EXCLUDE4.T2B2013.PROD.txt (where xx is your institution number)

NOTE: Files with invalid filenames will be rejected by the server and deleted.

Deceased Exclusions files are due by Tuesday, October 30, 2018 and the completed certification form is due by November 16, 2018.

Include **ONLY** those records of students in the cohort who are deceased. If your college has no deceased students in the cohort, submit through TIBCO only the certification form and indicate "No" on the form.

Records not in the original cohort will not be loaded.
