EXECUTIVE SUMMARY

This rule incorporates statewide articulation agreements that guarantee the award of a specified number of college credits to students who have earned the specified industry certification towards the award of a specific Associate of Applied Science degree or Associate of Science degree program at a Florida College System institution. Approval of this rule will add the following six agreements to the Gold Standard Career Pathways Articulation Agreements of Industry Certification to AAS and AS Degree Programs for the 2017-2018 Academic Year:
