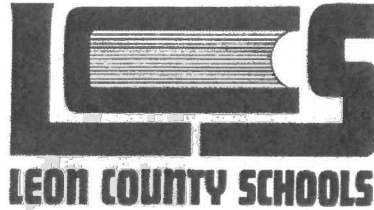

To Whom It May Concern:

The Leon County School Board unanimously voted to deny the Tallahassee Classical Charter School application on April 24, 2018. The applicant is appealing the denial. As per Section 1002.33(c), F.S., our response to the applicant's appeal is below:

The Application is Deficient in the Areas of Diversity, Outreach to Low Performing Students, and Provision of ESE Services

While our Leon County Schools Charter School Application Review Committee, voted to recommend approval of the application to me, evaluation sheets (Exhibit 1: Evaluation Sheets) completed by committee members and shared with the Leon County School Board contained comments indicating that some committee members had concerns about whether the application adequately addressed how the school would recruit and serve a population as diverse as that of the district, as per Section 1002.33 (10)(e)4,F.S., and whether the applicants had the intent to fulfill the purpose of increasing learning opportunities for all children, with a special emphasis on low-performing students and reading, as mandated by Section 1002.33, (2)(b)2. There were also comments questioning the intent of the applicants relative to the provision of services to students with disabilities.

The Leon County School Board considered the application at two different meetings on April 10, 2018 and April 24, 2018. Prior to voting, individual board members reviewed the evaluation sheets completed by the Leon County Charter School Application Review Committee,

the charter school application (Exhibit 2: Classical Charter School Application), and data readily available at the FLDOE EDSTATS website (which will be discussed in greater detail below), as is noted in the attached transcripts (Exhibits 3 and 4: Transcripts for April 10, 2018 and April 24, 2018 Leon County School Board meetings). Upon review of the application, the evaluation sheets, the FLDOE data, and after affording the public an opportunity to be heard at both meetings, the Leon County School Board unanimously voted to deny the application because: it failed to adequately address:

- 1) how the proposed Tallahassee Classical charter school would make reasonable efforts, in accordance with federal law, to achieve a racial/ethnic balance reflective of the community it serves or within the racial/ethnic range of other public schools in the school district;
- 2) how it would increase learning opportunities for all students, with the special emphasis on low-performing students and reading;
- 3) how it would provide services to students whose needs could not be adequately met in the regular classroom, so as not to discriminate against students with disabilities served in Exceptional Student Education programs (ESE) as is required by section 1002.33 (7)8., F.S., and by the state charter contract.

FLDOE EDSTATS Data- A portion of the data collected and discussed by Leon County School Board members during the April 10th and April 24th meetings documented that the classical charter schools linked to the Barney Initiative (Exhibit 5: List of Florida charter schools linked to the Barney Initiative as identified by their website) are serving percentages of black students, students with disabilities, and students eligible for free/reduced lunch below the percentages served by the school districts in which these charter schools are located. Applicant relies on parents to transport students and/or to arrange carpooling on their own rather than funding bus transportation, which would create barriers to access for students eligible for free/reduced lunch, as can be documented by the (Exhibits 6 and 7: Leon County Schools transportation information), data which shows the racial makeup of students using public school bus transportation in Leon County Schools. While the Application indicated that all students would have an equal opportunity to apply to and be selected for admission, current data shows that the classical charter schools located in Florida do not appear to be acting in good faith relative to meeting statutory and charter contract requirements regarding the achievement of a balance reflective of the community served in the other Florida districts in which they operate (Exhibit 8: FLDOE data). Allowing this charter school to open in Leon County, when classical charter schools in Florida do not appear to be making every effort to comply with statutory requirements related to diversity and serving students with disabilities, would likely result in further segregation of public schools and a continuation of practices that limit access to charter schools for students with disabilities in Leon County. As legislative action has limited the ability of a school district to negotiate its own charter contracts with charter schools due to the requirement to use a state charter template that can only be changed if a charter applicant agrees as per Section 1002.33 (7), F.S., which states, “Any term or condition of a proposed charter contract that differs from the standard charter contract adopted by rule of the State Board of Education shall be presumed a limitation on charter school flexibility,” it is unlikely that the issues identified above can be addressed through negotiation. The only action available to the Leon County School Board was denial of the application.

Districtwide Capacity Demonstrates that Charter School Facility Not Warranted

An additional reason for the denial of this application by the Leon County School Board was to support my recommendation for denial as described in the attached school board agenda items (Exhibits 9 and 10: Leon County School Board Agenda Items). Florida's statutes delineate the responsibilities of public school superintendents and local school boards related to the provision of facilities. A public school superintendent is mandated under 1005.51(6), F.S., to approve the establishment of schools as needed to provide adequate educational opportunities for all public school students in the school district. A district school board has a duty under 1001.42, F.S., to provide adequate educational facilities for all children. In a letter dated 9/9/2016 (Exhibit 11: Correspondence from FLDOE to Leon County Schools), the Florida Department of Education communicated to Leon County Schools that until Capital Outlay Full-Time Equivalent (COFTE) enrollment for Leon County Schools shows a projected level of growth that creates a need for new public student stations, the current district facilities will be adequate and in suitable condition for the foreseeable future, in accordance with 1013.31 and 1013.35, F.S. Therefore, I could not, in good faith, recommend approval of a charter application that, if approved, would result in expenditures of public taxpayer dollars by Tallahassee Classical to lease and/or construct an additional public school facility in Leon County.

Partially Meets the Standard:

The response addresses most of the criteria, but the responses lack meaningful detail and require important additional information.

Does Not Meet the Standard:

The response lacks meaningful detail, demonstrates lack of preparation, or otherwise raises substantial concerns about the applicant's understanding of the issue in concept or ability to meet the requirement in practice.

Authorizers are encouraged to align their application review process with the Florida Principles and Standards for Quality Authorizing.

- Acknowledgement of and general plan to meet FERPA requirements.

- An understanding and commitment to collaborating with the sponsor to ensure that placement decisions for students with disabilities will be made based on each student's unique needs through the IEP process.
- An appropriate plan for evaluating the school's effectiveness in serving exceptional students, including gifted.
- A realistic enrollment projection (SWD) and a staffing plan that aligns with the projections.

- Evidence that applicant understands and intends to implement open meeting and records laws.
- Clear policy and plan for dealing with conflicts of interest.
- Appropriate and clear role for any advisory bodies or councils if included.
- An outline of a grievance process (or policy) that will simultaneously address parent or student concerns and preserve appropriate governance and management roles.
