## **Operational Details**

#### When will these courses be available?

- Courses will be offered for free from March 25, 2020 through June 30, 2020
- Public school districts must contract with FLVS by May 31, 2020
- Districts who wish to renew after July 1, 2020, will have standard licensing rates and fees apply.

#### Which courses will be available?

• FLVS developed courses only, which include Core, AP, Electives and CTE courses.

#### Are there any restrictions?

- Only available in Florida to all public school students.
- Only valid for new student enrollments related to COVID-19 school disruptions.
- Courses are limited to 100 per school district.
- Courses are limited to course content only and do not include course assessments.
- Additional service fees and restrictions may apply to services beyond access to digital courses.
