OTHER PERTINENT FIXED CAPITAL OUTLAY NOTES

Specific bill language (Section 197) provides funding contingent upon the Department of Financial Services receiving and depositing into the General Revenue Fund the second distribution of the state's allocation from the federal Coronavirus State Fiscal Recovery Fund (Public Law 117-2). These are nonrecurring appropriations from the General Revenue Fund authorized for the 2021-2022 fiscal year for the purpose of responding to the negative economic impacts of the COVID-19 public health emergency. Included in this section is a Deferred Building Maintenance Program for \$843,725,327 to address negative economic impacts to the state resulting from the COVID-19 public health emergency by investing in deferred maintenance needs in Florida College System institutions (\$400,000,000) and state universities (\$443,725,327). Also included in Section 197 is \$175,818,689 for 18 fixed capital outlay projects for the Florida College System.
