Northwestern Middle School

- Duval County School District is requesting a new Turnaround Option Plan (TOP) for Closure at Northwestern Middle School.
 - Since 2000, the highest school grade achieved was a C in 2006.
- In preparing for closure, only 7th and 8th grade students attended the school during the 2019-20 school year.
- The projected 7th and 8th grade students for the 2020-2021 school year will be assigned to Matthew Gilbert or Lake Shore Middle School. Both schools received a 2019 school grade of C.
