
# **NAEP 2007**

Four States and Jurisdictions Make Gains in Reading at Both Grades



#### Compared with 2005,

- 4 states and jurisdictions (District of Columbia, Florida, Hawaii, and Maryland) improved at both grade levels,
- 13 states and Department of Defense schools improved at Grade 4 only,
- 2 states improved at Grade 8 only,
- 2 states declined at Grade 8, and
- 30 states showed no significant change at either grade.



# What are the benefits of NAEP?

#### **NAEP** provides:

- Student performance data in disaggregated groups, allowing policy makers to examine grade-level student achievement across states
- Data that states can use as an external "check" on the quality and effectiveness of their state assessment systems
- An opportunity for Florida to compare the achievement of its students to that of students across the nation

Florida students are encouraged to participate in NAEP to further educational progress. Since no student-level results are generated, participation provides students, parents, and schools, with a low-pressure, enriching experience that benefits our nation and the State of Florida.



# What is NAEP?


- Authorized by Congress and implemented in 1969, the National Assessment of Educational Progress (NAEP) is the only ongoing nationally representative measure of what students in the United States know and can do in various subject areas.
- NAEP at the state level began in 1990, and in 2003 NAEP participation became mandatory for all states and territories under the federal No Child Left Behind Act.
- NAEP is based on frameworks established by the National Assessment Governing Board (NAGB), and test parts are assembled together to form projected state and national scores.
- Each student in a selected sample takes only a portion of the assessment. Reports are produced on the performance of groups of students at a given time and across time, and proficiency is reported at three levels: Basic, Proficient, and Advanced.
- Results are used to compile national data, and no results are generated for districts, schools, or individual students.




# How Do Florida's Students Compare With The Nation's?

NAEP Grade 4 Reading and Mathematics Results













### NAEP Grade 8 Reading and Mathematics Results

NAEP was not designed to provide a developmental scale between Grades 4 and 8, which is why scores on the two scales are not directly comparable. Reading and Mathematics are different tests and therefore are reported on different score scales which cannot be correctly compared.
