

Organizations and Consortiums with Approved Professional Learning Systems

Pursuant to section 1012.98(6), Florida Statutes, private school organizations and charter school consortiums with ten or more member schools in Florida may submit a professional learning system to the Florida Department of Education for review and approval.

Professional learning systems must include a professional learning catalog (formerly known as a master inservice plan) that outlines all professional learning opportunities available to member schools, and may include a professional education competence program for instructional staff who hold a Florida Temporary Certificate.

Arrangements to participate in learning opportunities are made between the organization and its member schools, and the organization reports participation information to the department.
