Chapter FFEA PSA Competition

TOPIC: Create a public service announcement (PSA) that celebrates and promotes FFEA.

WHAT IS A PUBLIC SERVICE ANNOUNCEMENT?

- A short video presentation promoting an issue or topic important to society.
- Has a goal of creating public awareness.
- Should present the issue in an engaging and creative manner.

ELIGIBILITY:

- Entries will be categorized according to the school level (high school and postsecondary).
- Each chapter may submit only one PSA.
- Presentations are to be created by student members.

SUBMISSION REQUIREMENTS:

- Submissions should be faithful to the theme, "Teach...it's a Choice and an Adventure!"
- The PSA should be created with some combination of copyright free stills, text, video, music, sound, effects, and/or student voice-overs.
- Length: 60 seconds maximum.
- Multimedia elements must adhere to copyright and fair use guidelines. Submissions that include ANY
 copyrighted music, footage, or images will NOT be accepted. Entries that violate copyright or fair use
 guidelines will be disqualified. (Please see additional information on the following page.)
- Student creator(s), school, sponsoring teacher(s), and the source of any non-original, multimedia elements (images and sounds) and permissions must be identified in the credits (credits may be provided as a last, single frame).
- By submitting your works, you are releasing publication and talent presentation rights to the Florida
 Department of Education and are certifying that the work is free of copyright violations. All accepted
 submissions may be featured on the Florida Department of Education website.
- Only one submission per chapter is permitted.
- Presentations are to be created by student members.
- The PSA must be submitted on CD or flash drive in either a QuickTime (.mov) or Windows Media Video (.wmv) format. ALL OTHER FORMATS WILL BE DISQUALIFIED.

SCORING:

- The PSA will be scored using the attached rubric. The maximum total number of points possible is 100.
- The first, second and third place winners will be announced during the closing session on Sunday. The first place winning PSAs will be shown.

DEADLINE:

Submit two (2) copies of the completed PSA and entry form to the following address no later than **Friday, November 20, 2015.** Entries postmarked after this date will be disqualified.

Chapter FFEA PSA Competition

USE OF COPYRIGHTED MATERIAL:

The video you submit for the Florida Future Educators of America's PSA competition must be an original work. No copyrighted material (music, images, etc.) or trademarks (company names, logos, brands, etc.) may be used unless you own or have a license to use the material for this contest. **Written permission must be obtained and provided with your video submission for all copyrighted or trademarked materials.**

<u>Music purchased from Amazon or iTunes for listening **DOES NOT** include the rights to sync it up with your <u>images and repackage it as a video.</u> Those rights are called synchronization rights and commercial music sync rights are expensive. Some people assume that the use of commercial music for nonprofit or school use is 'fair use' and that is not true. The 'fair use' exception to copyright is rather limited and does not include a submission to the Florida Future Educators of America's PSA competition.</u>

If you want to get permission to use copyrighted music, you can visit http://www.copyrightkids.org/ to find out more about how to write a letter to make the request. The site includes sample letters and links to music publisher contacts. There are several sources of music for videos, some of which are free and others that have to be purchased.
