It is designed to help increase access to AP and to ensure that no student who has the chance of succeeding in AP is overlooked.

## I. <u>2014-2015 Assessments</u>

On March 17, 2014, Commissioner Stewart announced the selection of the American Institutes for Research (AIR) to develop, administer, score, and report assessments that are aligned to Florida's standards in English language arts/literacy and mathematics beginning in 2014-15.

The new statewide assessments will be ELA Assessments for Grades 3-11, Mathematics Assessments for Grades 3-8, an Algebra 1 Assessment, a Geometry Assessment, and an Algebra 2 Assessment. The current FCAT 2.0 Science Grade 8, Biology EOC Assessment, Civics EOC Assessment, and US History EOC Assessment will remain.

#### II. Summer 2014 Bridge Event

The Improving Mathematics Instruction Research Alliance within the Regional Educational Laboratory Southeast (REL-SE) at Florida State University (FSU) has put together a bridge event for Florida teachers this summer. This workshop is geared towards 1) presenting information on the evidence supporting the instructional practices for teaching fractions to students; 2) engaging in interactive activities that also include working through common misconceptions; 3) connecting the activities to the first part of the lesson study cycle; 4) addressing recommendations in a developed Practice Guide on Fractions; and 5) discussing what a Practice Guide is and how it can be used.

This event is the first of hopefully many more to come! This initial research to practice event is targeting all teachers (including ESE and ESOL) who teach mathematics in the range of grades 3-6. The premise is to have a primary site with two remote sites. The first scheduled date is Tuesday, June 24th, from 1-4:30 p.m. The primary site will be in Jacksonville with satellite sites in Tallahassee and Tampa. This event will be repeated on Thursday, June 26th, again from 1-4:30 p.m. The primary site will be in Miami with satellite sites in Fort Lauderdale and Orlando. Each location will be capped at 120 participants, to keep things manageable.

**Award for Excellence in Creative Teaching** - FLAG established this award to recognize teachers of the gifted that construct creative learning environments in which students and teachers alike explore, imagine and engage in a variety of thought provoking experiences.

## **Broward County School District Honored for Going Green**

The Broward County School District is one of only nine districts in the nation receiving the prestigious Green Ribbon Schools District Sustainability Award for 2013-14. The district was recognized for their exemplary efforts to reduce environmental impact and utility costs, promote health and wellness of students and staff, and provide effective environmental and sustainability education that includes civics, STEM (science, technology, engineering and mathematics) and green career pathways.

The Broward County School district has shown an incredible commitment to becoming a high-performing green district. They are recognized for continuing growth in environmental stewardship initiatives such as school gardens, wildlife habitats, classroom recycling programs and an integrated environmental curriculum. At the district level, various departments within the district implemented energy savings techniques that resulted in reduced energy costs of more than \$34 million, saving \$11 million in energy costs just last year.

Over the past two years, the district saved 2.2 million gallons of water through outdoor irrigation systems and an additional \$323,000 in reduced potable water and energy. The district also sponsors district-wide health and wellness initiatives such as Florida Agriculture in the Classroom, Growing Healthy Kids with Holy Cross Hospital, Jump Rope for Heart, Farm to School, 4-H Clubs, Y-FIT-YMCA and Project Bridge Anti-Bullying Program and Policy. The Broward County School District is also recognized as a Florida Healthy School District at the silver level by the Florida Coordinated School Health Partnership, Florida Action for Healthy Kids and Florida Association of District School Superintendents.

The Green Ribbon Schools Award program is part of a U.S. Department of Education effort to identify and share practices that improve student engagement, promote higher academic achievement and increase graduation rates and workforce preparedness, as well as increasing energy independence and economic security. ### Opportunity to be Recognized as a Florida Healthy School District

Since 2009, Florida's Coordinated School Health Partnership (CSHP), Florida Action for Healthy Kids (FLAFHK), and the Florida Association of District School Superintendents (FADSS) have had the honor of recognizing twenty-six Florida districts as Healthy School Districts. Recognition is based on submission of the completed Florida Healthy School District Self-Assessment. The instrument is designed to assess the status of policies and practices that support the highest levels of health and academic achievement for students and staff.

Recognition is awarded for a period of two years. If a bronze, silver, or gold level score is achieved, your district will be featured in various statewide publications, recognized at your school board meeting, as well as CSHP and FADSS meetings, and featured on the Florida Healthy District Web Site at <a href="https://www.healthydistrict.com">www.healthydistrict.com</a>. Additionally, your district will be eligible to participate in the Healthy District Collaborative supported by the Florida Departments of Health and Education.

If your district has not applied, your designation is expiring, or is not currently recognized, we encourage your team to complete the application. Achieving designation as a Florida Healthy School District demonstrates the commitment of district leadership to their primary mission of educating students by providing supportive environments that nurture physical, social, and psychological health. District infrastructure is critical to sustainability and overall success as demonstrated across the recognized districts.

Regardless of whether you apply for recognition we would like to encourage your district team to complete the tool and use the self-assessment as an internal guide. Teams that completed the tool reported that the process improved their knowledge of standards, legislation, and best practices; and enhanced their ability to maximize resources and eliminate duplication.

The self-assessment is based on the eight component areas of the Centers for Disease Control and Prevention's Coordinated School Health model. It focuses on district infrastructure, policy, programs, and practices identified from national and state guidelines, best practices, and Florida statutes. We all know that health and academic success are interrelated. This tool provides a method for districts to assess areas of success and opportunities for improvement in their efforts to remove barriers to learning.

The self-assessment tool is online and very user friendly. The system allows team members to complete, edit and update their district assessment on an ongoing basis. Multiple team members can view and work on the tool simultaneously, and see the updates as they occur. Users from other districts are not able to view your assessment. The tool automatically tracks progress toward completion and tabulates points toward recognition. Each member of the district team will need to request a password

to log-in to the online system by sending an email to <u>cshpmailbox2@gmail.com</u>. Applications are downloaded on June 1 annually to be evaluated for recognition as a Florida Healthy School District.
