<b>School Improvement Funds/Timelines</b>	<ul style="list-style-type: none"> <li>• 1003(a) – Released on 9/30/11</li> <li>• FY09 1003(g) and FY10 1003(g) – collaborate with Fred Heid</li> <li>• Explained appeals/AYP status process</li> <li>• DOE200s some issued, others on the way</li> </ul>
<b>ARRA</b>	<ul style="list-style-type: none"> <li>• Spend the funds by September 30, 2011.</li> </ul>
