SUBJECT: July 2014-15 Student Transportation Survey Information and 2014-15 Student Transportation General Instructions

The July 2014-15 student transportation survey will be conducted the week of July 7-11, 2014. The Automated Student Information System (student transportation format) will be used by all districts to transmit their July student transportation information.

The student transportation reporting requirements have been revised for 2014-15. Please refer to the attached 2014-15 Student Transportation General Instructions for assistance with student eligibility, reporting criteria, instructions for the Automated Student Information System and reporting deadlines.

A list of the reporting deadlines is attached for your convenience. The deadline for initial full submission of July survey data is Friday, July 25, 2014. Any corrections or revisions to this data must be addressed by Tuesday, September 30, 2014, the system cutoff date. The attached form letter, which certifies the adjusted student membership and the number of buses reported on the database, must be signed by the superintendent or designee and submitted no later than Friday, October 3, 2014. The July student transportation information provided in this letter must match that reported in the district database as of the system cutoff date. **Districts may use Transportation Report F63499 or F70092 to verify adjusted membership and bus information recorded in the database for use in the certification letter.** The information in
