Student Eligibility

- **All students** = Public, private and home education students
- **Eligibility per s. 1002.455** = Students must meet one of the following criteria:
 - prior-year in Florida public school,
 - siblings of virtual students enrolled in current and end of previous year,
 - military dependents who recently moved to Florida,
 - students eligible to enroll in grades K-1,
 - students in grades 2-5 enrolling in full-time virtual programs.



District Virtual Instruction Program (VIP)

A district VIP shall consist of the following:

- Full-time and part-time virtual instruction for students in grades K-12
- Full-time or part-time virtual instruction for students in dropout prevention and academic intervention programs, DJJ programs, core courses to meet class size requirements and Florida college courses



District Virtual Instruction Program (VIP)

Districts have the following options to offer VIPs:

- Offer a district-operated program
- Contract with Florida Virtual School (FLVS)
- Establish a franchise of FLVS
- Contract with an approved provider
- Enter into an agreement with another school district
- Enter into an agreement with a virtual charter school
- Contract with a Florida college

District Franchises of FLVS

- District enters into agreement with FLVS
- District provides administration and teachers and serves district students
- FLVS provides curriculum, LMS, SIS, professional development for teachers and administrators, mentoring, and other tools and resources



District Franchises of FLVS

- District Franchises offer online courses for public, private and home education students in grades 6-12
- District Franchises will begin offering courses for students in grades K-5 in 2014-15. Elementary students must meet one of the eligibility criteria.
- Districts may use their district franchises as one of their options for VIP



District Virtual Course Offerings

- K-12 courses in Course Code Directory
- Eligible district students and eligible students from other districts may enroll in these online courses
- District of instruction, rather than home school district, reports course completions for funding



Virtual Charter Schools

- May serve eligible district students in grades K-12
- Must offer full-time virtual program
- Must contract with a DOE-approved provider or FLVS for its virtual education program
- Must submit application to school district and be approved to operate a virtual charter



General Funding and Reporting

- Report in all appropriate surveys
- Funding based on Successful Completions
 - K-8: courses or prescribed level of content successfully completed
 - 9-12: course credits successfully completed
- Districts/FLVS receive estimated funding throughout the year



General Funding and Reporting

- Full-time virtual programs/schools may report FTE in all FEFP programs:
 - 101-103
 - 111-113
 - 130
 - 254-255
 - 300
- Part-time virtual programs/schools may report FTE in FEFP Basic Education and Career Education only:
 - 101-103
 - 111-113
 - 300

School Numbers for Virtual Options

- **7001** for Provider-operated VIP
- **7023** for District-Operated VIP
- **7004** for franchises*
- **7006** for Virtual Course Offerings
- Traditional school number for online courses offered by traditional schools
- Virtual Charter School numbers assigned individually

*Even if a franchise is used to meet VIP requirements, report all franchise students under **7004**



Surveys 2 and 3

- Submit same record formats as for students in other district schools and programs
- Report 0 FTE on student course records
- Report Class Minutes, Weekly even though the reported FTE is zero.
- Report all virtual students who are enrolled for more than 14 days through date certain of survey period



Course Grade Data Element

- Added to the Student Course Record in 2013-14
- Report IP or appropriate withdrawal code (WP or WF) in Surveys 2 and 3
- Report actual course grade in Survey 4



Surveys 2 and 3 – VIP Provider Codes (7001)

- Provider-operated programs use school number 7001
- Provider codes assigned to approved providers, FLVS and Florida colleges
- *Provider codes reported on student course records*
- Provider Code Table in Appendix CC of student database manual:
http://www.fldoe.org/eias/dataweb/database_1415/appendcc.pdf
- District-operated programs use school number 7023 and do not have provider codes.
- Provider Codes must be reported correctly in Surveys 2 and 3 to ensure accurate provider grades.

VIP Provider Data Verification

- Imperative to collaborate and share information with Provider to ensure accuracy of data for provider grades
- Verify data throughout school year (can use district reports)
- **Run DOE EIAS reports during Surveys 2 and 3 and share with provider**
- Involve providers in Accountability Matching process during Survey 3
- Make sure student ID and provider codes are accurate
- Course numbers should match in Surveys 2, 3, and 4



EIAS Report F71198

Full-Time Virtual Students

- Available for Surveys 2 and 3
- Purpose is to verify student data for school 7001
- Separate report created for each provider
- Report lists student name, ID, grade level, VIP provider code and name
- **Please share with provider early in process for both surveys**



Reporting Home Education Students in Part-time Virtual Programs

- School of Enrollment = N998
- School of Instruction = Virtual School #
 - Grades K-1:
 - VIP (7001 or 7023)
 - District Virtual Course Offerings (7006)
 - District franchise (7004)
 - FLVS Part-time (District 71, School 0700)
 - Grades 6-12:
 - District franchise (7004)
 - FLVS Part-time (District 71 – 0500, 0600))

Reporting Home Education Students in Part-time Virtual Programs

- Immunization Records and Reporting
 - Required if they enter a district school for any reason (testing, classes, extracurricular)
 - If not required, zero fill on Federal/State Indicator Status Record Format

Survey 4

- Report all course records (successful and unsuccessful)
- Report course grade on Student Course Record
- Report FTE >0 for all successful completions
- If the reported FTE exceeds 1.0 FTE, the DOE will recalibrate the FTE down to 1.0 FTE in proportionate shares across all course completions.
- Do not report non-virtual courses for part-time virtual students

Survey 4 Record Formats

- Student Demographic Information
- Student Course Schedule
- Teacher Course
- Exceptional Student (ESE)
- English Language Learners (ELL)



Reporting FTE Beyond 180 Days

FTE membership in programs scheduled for more than 180 days is limited to:

- Juvenile Justice Education Programs
- The Florida Virtual School
- Virtual instruction programs and virtual charter schools for the purpose of course completion and credit recovery

Survey 5

Survey 5 information should be reported for virtual students as for other district students

Survey 6

- Count for Legislature
- Report students enrolled on **8/29** and **9/12**
- Student Demographic Information format only

Survey 7

Purpose:

- Pre-Gridding for CELLA
- ELL Students can be reported in Full-Time virtual programs

Reporting for Reading Progress Monitoring

Survey 8

- For districts/schools using FAIR for Progress Monitoring
- July to September

Accountability

- Performance funding based on successful completions
- District-operated full-time programs receive school grade (VIP and franchise)
- Full-time providers for VIP receive statewide school grade or school improvement rating
- School choice option for parents
- For virtual charters, student performance requirements in charters
- DOE evaluation report for part-time virtual providers
