## Florida Association for Career and Technical Education (FACTE) Quality Assurance and Compliance Monitoring Report

#### I. INTRODUCTION

The Florida Department of Education (FDOE), Division of Career and Adult Education (division), in carrying out its roles of leadership, resource allocation, technical assistance, monitoring and evaluation, is required to oversee the performance and regulatory compliance of recipients of federal and state funding. The Quality Assurance and Compliance section is responsible for the design, development, implementation and evaluation of a comprehensive system of quality assurance including monitoring. The role of the quality assurance system is to assure financial accountability, program quality and regulatory compliance. As stewards of federal and state funds, it is incumbent upon the division to monitor the use of workforce education funds and regulatory compliance of providers on a regular basis.

#### II. AUTHORITY

The FDOE receives federal funding from the U.S. Department of Education (USDOE) for Career and Technical Education (CTE) under the Carl D. Perkins (Perkins) Career and Technical Education Act of 2006 and for Adult Education (AE) under the Adult Education and Family Literacy Act of 1998. FDOE awards subgrants to eligible providers to administer local programs. FDOE must monitor providers to ensure compliance with federal requirements, including Florida's approved state plans for CTE and adult education/family literacy. Each state shall have procedures for reviewing and approving applications for subgrants and amendments to those applications, for providing technical assistance, for evaluating projects, and for performing other administrative responsibilities the state has determined are necessary to ensure compliance with applicable statutes and regulations pursuant to 34 CFR 76.770, Education Department General Administrative Regulations (EDGAR) and the Uniform Grant Guidance (UGG) for grant awards issued on or after December 26, 2014. The Florida Department of Education, Division of Career and Adult Education is required to oversee the performance of subgrantees in the enforcement of all laws and rules (Sections 1001.03(8) and 1008.32, Florida Statutes).

Additional citations noting pertinent laws and regulations and authority to monitor are located in the 2015-2016 Quality Assurance Policies, Procedures, and Protocols, Module A, Section 1.

#### III. QUALITY ASSURANCE POLICIES, PROCEDURES, AND PROTOCOLS

The Quality Assurance Policies, Procedures, and Protocols manual was revised in the 2015-16 program year. The manual is provided to each provider prior to the monitoring visit. The manual provides a summary of each facet of the monitoring design and the process. It also contains protocols that may be used as agencies are monitored or reviewed. References may be made to the manual in this document; it is located on the division's website at <a href="http://fldoe.org/academics/career-adult-edu/compliance">http://fldoe.org/academics/career-adult-edu/compliance</a>.

#### IV. PROVIDER SELECTION

Various sources of data are used throughout the implementation of the quality assurance system. The monitoring component of the system is risk-based.

Risk assessment is a process used to evaluate variables associated with the grants and assign a rating for the level of risk to the department and the division. A risk matrix, identifying certain operational risk factors is completed for each provider. The risk matrix for each program monitored is located in Appendix A.

The results of the risk assessment process and consideration of available resources are used to determine one or more appropriate monitoring strategy(ies) to be implemented. The monitoring strategy for the Florida Association for Career and Technical Education was determined to be an onsite visit. Notification was sent to Ms. Marsan Carr, director, on August 11, 2015. The designated representative for the agency was also Ms. Marsan Carr. The onsite visit to the agency was conducted October 6, 2015, by two representatives of the Quality Assurance and Compliance section of the division: program specialists, Joycelyn Brinson and Dr. Shahrokh Massoudi.

#### Records Review

#### VII. RESULTS

- **A.** <u>ADMINISTRATION</u> refers to the management and/or supervision of programs, structure of programs and services, grant oversight, and other administrative areas.
  - FACTE is governed by its board of directors, officers and executive director.
  - The board of directors are elected by members from each CTE division around the state of Florida.
  - Employed are three part-time individuals who work on an hourly basis.
  - The executive director has been employed with FACTE for 14 years.
  - The executive director reports directly to the President and Board of the Organization.
    - The executive director is well experienced in representing the Organization with the Florida Legislatures.
  - Board meetings are held a minimum of four times a year.
  - FACTE has approximately 750 members on record that pay dues on an annual basis.
  - Memberships are open to any persons who have an interest in CTE (Predominantly consisting of teachers and instructors).
  - In 2015, at the annual FACTE conference, participants made numerous presentations, highlights include:
    - Over 500 attendees
    - Over 80 consecutive sessions, related to CTE.
    - o The state Board of Education Chair, Marva Johnson, was in attendance and presented.
    - The American Association of Career and Technical Education (ACTE) policy director Alisha Hyslop was a presenter.

- **C. <u>FINANCIAL</u>** refers to aspects of the federal fiscal requirements that providers must meet when expending federal funds, including financial management, procurement, inventory management, and allowable costs.
  - Sample of invoices and deliverables for 2013-14 grants were reviewed.
  - Documentation of expenditures were organized and completed.
  - A Certified Public Accountant (CPA) reviews all expenditures, assuring internal control.
    - o Accounting software captures each grant by expenditure, allowing the CPA to review expenditures to ensure consistency with approved grants.
  - The annual agency review conducted by the CPA was available and contained no findings.
  - An independent audit is conducted annually by another firm.
- **D.** <u>COLLABORATION</u> refers to the collaborative agreements, partnerships, or memoranda of understanding (MOUs) that are in place to benefit an agency's programs and students.
