STUDENT END OF YEAR STATUS – REJECT RULES

 **16. Withdrawal Reason code must be DNE, W01, W02, W3A, W3B, W04, W05, W12, W13, W15, W18, W21-W26, WPO or ZZZ. -record rejected-**

EXAMPLE

The second record listed below would be loaded to the data base assuming no other reject rule would cause its rejection. The first and third records would be rejected because the code for Withdrawal Reason is not valid.

District Number, Current Enrollment	Student Number Identifier, Florida	Withdrawal Reason
* 30	301234567X	XXX
30	301234568X	W12
* 30	301234569X	W34

DISTRICT RESPONSIBILITY

If the rejected records should not have been submitted, no action is required. However, if the district wishes the data in the rejected records to be loaded to the data base, the district must correct the Withdrawal Reason code and resubmit the records.

STUDENT DEMOGRAPHIC – REJECT RULES

16.

- If Survey Period Code = 1, 2, 4, 5, 7 or 9, then District Number, Zoned School must be filled with zeroes.
- If Survey Period Code = 3, then District Number, Zoned School must be 00-67.

(This edit does not apply to Survey Periods 6 and 8.) -record rejected-

EXAMPLE

The first two records listed below would be written to the data base assuming no other reject rule would cause their rejection. The third record would be rejected because the District Number, Zoned School is outside the specified range.

Survey Period Code	District Number, Zoned School	School Number, Zoned School
01	00	0000
02	00	0000

DISTRICT RESPONSIBILITY

If the rejected records should not have been submitted, no action is required. However, if the district wishes the data in the rejected records to be loaded to the data base, the district must correct the District Number, Zoned School and resubmit the records.

STUDENT DEMOGRAPHIC – REJECT RULES

17. If Survey Period Code = 1, 2, 4, 5, 7 or 9, then School Number, Zoned School must be filled with zeroes.

→ • If Survey Period Code = 3 and District of Instruction is not 71 and School of Enrollment

-
- Is in the range 0001-9899 but not 3518, 7001, 7004, 7006, 7023 and
 - school function setting is not D (DJJ) on MSID and
 - the Charter School Status is Z (not Charter) on MSID and
 - the Accountability ESE Center is Y or the Primary Service Type is B (Alternative Education) on MSID

-
- then School Number, Zoned School must be an active school for the District Number, Zoned School on the Master School Identification file unless District of Instruction is 68 in which case School Number, Zoned School can also be zeroes.

- All others, School Number, Zoned School must be zeroes.

(This edit does not apply to Survey Periods 6 and 8.) -record rejected-

EXAMPLE

The first two records listed below would be written to the data base assuming no other reject rule would cause their rejection. The third record would be rejected since the School Number, Zoned School is not zero- filled for survey 2. The fourth record would be rejected since the School Number, Zoned School is not a valid number on the Master School Identification file.
