A code indicating the type of program(s) in which the student participated.

Note: In surveys 2 and 3 the student should be in the program during survey week to be reported. Also, in surveys 2 and 3 only one code is reported. Codes R and E take priority because they are used to identify the proper status of students in the school grading system. In survey 5, in the Dropout Prevention Program Data format, report students who were served at any time during the school year and, for students participating in more than one program, school, or term, record the code for each program, in each term, at each school in which the student participates. In the Federal/State Indicator Status format, for surveys 7 and 5, report code Z.

Code	Definition/Example
A	<p>Disciplinary Programs:</p> <p>Programs designed to provide intervention for students who are disruptive in the traditional school environment. Note: This may include in-school suspension programs. This code does not apply to students who have been assigned to this program as an alternative to expulsion – use code E for these students.</p>
D	<p>Education Services in Department of Juvenile Justice Programs:</p> <p>Educational programs provided to students in Department of Juvenile Justice prevention (diversion), detention and commitment programs.</p>
E	<p>Alternative to Expulsion Programs:</p> <p>Programs designed for students who are subject to district school board policies for expulsion for repeated or serious offenders.</p>
N	<p>Non-School Institution for Neglected or Delinquent Students</p> <p>Student resides in a non-school institution for neglected or delinquent students as defined in Title I, Parts A and D of the Elementary and Secondary Education Act, as amended by Public Law 107-110. See the element Institution Number, Neglected /Delinquent for additional information.</p>
P	<p>Teenage Parent Programs:</p> <p>Educational programs which are designed to provide a specialized curriculum and other services to meet the needs of students who are pregnant, students who are parents or babies of TAP students.</p>
R	<p>Dropout Retrieval Programs:</p> <p>Alternative programs serving students who have officially been designated as dropouts.</p>
U	<p>Educational Alternative Programs:</p> <p>Educational programs which are designed to offer variations of traditional instructional programs and strategies for the purpose of increasing the likelihood that students who are unmotivated or unsuccessful in traditional programs remain in school and obtain a high school diploma or its equivalent. This code does not apply to students who are participating in this program as a retrieved dropout - use code R for these students.</p> <p>Note: Examples of Educational Alternative Programs include but are not limited to course modifications, credit recovery, integrated curriculum, alternative curriculum, flexible schedules and self paced curriculum.  14. For Survey Period Codes 2 and 3 , Dropout Prevention/Juvenile Justice Programs must be A, D, E, N, P, R, U W or Z. For Survey Period Codes 7 and 5, Dropout Prevention/Juvenile Justice Programs must be Z. -record rejected-

EXAMPLE

The second and third records listed below would be loaded to the data base assuming no other reject rule would cause their rejection. The first and fifth records are rejected for invalid codes. The fourth record would be rejected because the Dropout Prevention/Juvenile Justice Programs field is blank.

DISTRICT RESPONSIBILITY

If the rejected record should not have been submitted, no action is required. However, if the district wishes the data in the rejected record to be loaded to the data base, the district must correct either the FEFP Program Number or the English Language Learners: Instructional Model and resubmit the record.

STUDENT COURSE TRANSCRIPT INFORMATION - REJECT RULES

 22. If Course Assessment Status is B or C; then Credit Attempted, Course must be greater than Credit Earned, Course. -record rejected-

NOTE: Two decimal places assumed.

EXAMPLE

In the examples below, the second record would be loaded to the data base assuming no other reject rule would cause the records to be rejected. The first record would be rejected because the Credit Attempted, Course is less than the Credit Earned, Course.

If the Online Course Exempt code is D, then there must be a matching Exceptional Student record (based on District Number, Current Enrollment; Student Number Identifier, Florida; Survey Period Code; and Year) with at least one Exceptionality, Primary or Exceptionality, Other code that is not L or Z. – state validation-

EXAMPLE

The first Student End of Year Status record listed below which is marked with an asterisk would cause a message to be generated because the matching Exceptional Student record has only L and Z codes in Exceptionality, Primary and Exceptionality, Other. The second Student End of Year Status record would pass this edit. The third Student End of Year Status record would cause a message to be generated because a matching Exceptional Student record does not exist.
