CAREER AND TECHNICAL STUDENT COURSE SCHEDULE - REJECT RULES

9. Course Number must not contain blanks and must not be all zeros.

→ If School Number, Current Instruction/Service does not begin with C, P or U and if the Course Number does not begin with an alphabetic character; then the Course Number must be a valid Course Number in the Course Code Directory for the School Year, Course Taken.

→ If School Number, Current Instruction/Service does not begin with C, P, or U and if the Course Number begins with an alphabetic character, then the Course Number must be a valid Program Number in the Course Code Directory.

→ If School Number, Current Instruction/Service begins with C or U, then the Course Number must be on the Statewide Course Numbering System file for the School Year, Course Taken. -record rejected-

EXAMPLE

The second record listed below would be loaded to the data base assuming no other reject rule would cause its rejection. The first record would be rejected because the Course Number contains blanks. The third record would be rejected because the Course Number is not a valid Program Number in the Course Code Directory.

If the rejected records should not have been submitted, no action is required. However, if the district wishes the data in the rejected records to be loaded to the data base, the district must correct the Course Number and resubmit the records.

CAREER AND TECHNICAL STUDENT COURSE SCHEDULE - REJECT RULES

➔ 14. The School Year – Course Taken must be a valid school year greater than or equal to 0506 and less than or equal to the current school year. -record rejected-

EXAMPLE

The first record listed below would be loaded to the data base assuming no other edit would cause its rejection. The second record would be rejected because the School Year – Course Taken is all zeros. The third record would be rejected because the School Year – Course Taken is less than 0506. The fourth record would be rejected because the School Year – Course Taken is not a valid school year.

CAREER AND TECHNICAL STUDENT COURSE SCHEDULE - REJECT RULES

- ➔ **22. The Industry Certification Identifier (First) must not be the same as the Industry Certification Identifier (Second) or Industry Certification Identifier (Third) unless all Industry Certification Identifiers are ZZZZZZZZ. -record rejected-**

EXAMPLE

The third and fourth records listed below would be loaded to the data base assuming no other reject rule would cause their rejection. The first two records would be rejected because the Industry Certification Identifier (First), (Second) and (Third) are the same.

23. If the Industry Certification Identifier (Second) is a valid number that exists on Appendix Z of the DOE Information Data Base Requirements: Volume I -- Automated Student Information System Manual then the Industry Certification Identifier (First) must not be ZZZZZZZZ.

→ If the Industry Certification Identifier (Third) is a valid number that exists on Appendix Z of the DOE Information Data Base Requirements: Volume I -- Automated Student Information System Manual then the Industry Certification Identifier (First) and (Second) must not be ZZZZZZZZ. --record rejected-

EXAMPLE

The third and fourth records listed below would be loaded to the data base assuming no other reject rule would cause their rejection. The first two records would be rejected because the Industry Certification Identifier (First) is all Z's and the Industry Certification Identifier (Second) is a valid certification number.

26. If the Industry Certification Outcome (Second) is P or F then the Industry Certification Outcome (First) must not be Z.



If the Industry Certification Outcome (Third) is P or F then the Industry Certification Outcome (First) or (Second) must not be Z. –record rejected-

EXAMPLE

The second record listed below would be loaded to the data base assuming no other reject rule would cause its rejection. The first record would be rejected because the Industry Certification Outcome (First) is Z and the Industry Certification Outcome (Second) is F.

27. If the Industry Certification Outcome (Second) is P or F, then the Industry Certification Identifier (Second) must not be ZZZZZZZZ.



If the Industry Certification Outcome (Third) is P or F, then the Industry Certification Identifier (Third) must not be ZZZZZZZZ. -record rejected-

EXAMPLE

The first and third records listed below would be loaded to the data base assuming no other reject rule would cause their rejection. The second and fourth records would be rejected because there is an invalid relationship between the Industry Certification Identifier and the Industry Certification Outcome.

The first and third records would be rejected because there is an invalid relationship between the Industry Certification Identifier and the Industry Certification Outcome.

The third and fourth records listed below would be loaded to the data base assuming no other reject rule would cause their rejection. The first two records would be rejected because the Industry Certification Identifiers are invalid codes.

CAREER AND TECHNICAL STUDENT COURSE SCHEDULE - STATE VALIDATION RULES

50. If School Number, Current Instruction/Service does not begin with C, P and U, and if School Year – Course Taken is the same as School Year – Record Submission and if Course Number is not a valid CTE Course Number on the Career and Technical Education/Adult General Education Program Edit file (F61730) and if Course Number does not begin with an alphabetical character; then each Career and Technical Education Student Course record must have a matching Career and Technical Education Teacher Course record based on the key fields of District Number, Current Instruction/Service; School Number, Current Instruction/Service; School Year – Record Submitted; Course Number; Section Number; Period Number and Term. -state validation-

EXAMPLE

The first and second records listed below would pass the edit criteria. However, the third Career and Technical Education Student Course Schedule record would not pass this edit because of the failure to have a matching Career and Technical Education Teacher Course Schedule record based on the keys of District Number, Current Instruction/Service; School Number, Current Instruction/Service; School Year – Record Submitted; Course Number; Section Number; Period Number and Term.

2012-2013 Career and Technical Education Student Course Schedule

1. Submit a separate record in reporting period 5 for each Career and Technical Education (CTE) and applicable Career and Technical Education exceptional education course in which the student was in membership during the current school year and the associated summer session(s) for the current school year. Also submit a record for any Industry Certification Identifier and Industry Certification Outcome being reported that are not linked to a career and technical education course being reported, including those linked to a career-themed course. Include dual enrollment courses if the student took an industry certification or technical skill assessment listed in Appendix Z that is related to the dual enrollment course. Report prior year courses if the student was in membership during the current school year and took an industry certification or technical skill assessment that is related to the prior year course and for which the student has no related current year course.
2. SCHOOL YEAR: Report both the school year in which the course was taken and the school year of record submission. The school years will be the same for most records. The school year will be different when reporting students who took or attempted an industry certification or technical skill attainment assessment in a year subsequent to the school year in which the student took the course.
3. INDUSTRY CERTIFICATION IDENTIFIER: Report the Industry Certification Identifier from Appendix Z for students who took or attempted an industry certification or technical skill attainment assessment the current school year in the reporting district in an area that applies to the course in which the student participated. If none of these are applicable, submit all Z's in this field.
4. COURSE NUMBER: Report the career and technical education course number, the career-themed course number or basic course number, as appropriate. To report an Industry Certification Identifier and Industry Certification Outcome, report the career and technical education course number, career-themed course number or basic course number in which the certification was attempted/earned. If the course is not a career and technical education course report all zeros for the program number and no matching teacher course record is required.
5. CAREER AND PROFESSIONAL ACADEMY IDENTIFIER: Report the CAPE academy associated with the Industry Certification Identifier(s) reported. If there

is no CAPE academy associated with the reported Industry Certification(s) or if no Industry Certifications are being reported, report ZZZ in this field.

6. CAREER AND TECHNICAL EDUCATION/ADULT GENERAL EDUCATION PROGRAM CODE: Report the CTE/AGE Program Code for the CTE course number as listed in the Career and Technical Education/Adult General Education Program Edit file (F61730). If the course is not a career education course report all zeros for the program code and no matching teacher course record is required.
7. KEY FIELDS: The key fields for this format are item numbers 3, 4, 5, 6, 7, 8, 9, 10 and 11. If a key field needs to be changed, the record must be deleted and re-submitted as an add. For item number 8, Course Number, the range of valid values may be found in Secondary Career and Technical Education Data Base Handbook: Appendix D.
8. ERROR CODES: This field is used by the Department to report to districts the specific errors found in the record during the state edit process. This field should contain filler (spaces, blanks) when the record is transmitted to the Department.
