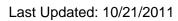
- 8. SCHOOL NUMBER, WHERE CREDIT EARNED: The School Number, Where Credit Earned field may contain 0001-9899, 9900, N997, N998, N999, C901-C928 Florida public colleges, U970-U980 Florida public state universities or P001-P999 eligible postsecondary non-public institutions.
- 9. COURSE NUMBER, SUBSTITUTED: This field is used with the Course Flag field. The presence of an asterisk (\*) as one of the four flags in the Course Flag field indicates that the course specified by the number in the Course Number field is a Department of Education approved substitute for the course specified by the number in this field.

For example: Course Number is 1802300 (Navy JROTC), Course Flag is \*, and Course Number Substituted is 0800300 (Life Management Skills). This indicates that the Navy JROTC course (18023000) will substitute for completion of Life Management Skills (0800300), satisfying the student's Life Management Skills graduation requirement.

- KEY FIELDS: The key fields for this format are item numbers 2-5 and 10-14. If a
  key field needs to be changed, the record must be deleted and re-submitted as
  an add.
