

TEACHER COURSE - REJECT RULES

36. If District Number, Current Instruction/Service is 71, then Facility type must equal 20. -record rejected-

DISTRICT RESPONSIBILITY

If the rejected record should not have been submitted, no action is required. However, if the district wishes the data in the rejected record to be loaded to the data base, the district must correct the Facility Type and resubmit the record.

5F. For Survey Periods 2 and 3, each Teacher Course Schedule record must have a matching Staff Demographic Information record based on District Number, Current Instruction/Service; Survey Period Code; Fiscal Year and Social Security Number, unless the course is a dual enrollment course at a postsecondary institution or school number is 7001 or 7006. Dual enrollment records are those with School Number, Current Instruction/Service of C901-C928, U970-U980 or P001-P999 and those with an alphanumeric course number at any School Number, Current Instruction/Service. -state validation 3-
