STUDENT COURSE TRANSCRIPT INFORMATION - REJECT RULES


1. **Survey Period Code must be 5 and must be correct for the submission specified by the district. -record rejected-**

EXAMPLE

The Survey Period Code as specified in the transmission JCL or in statements for tape transmission is identified as Survey Period "5". However, if records on the transmission have a Survey Period Code "3", all records updated, added, or deleted with this inconsistency would be rejected.

DISTRICT RESPONSIBILITY

If the rejected record should not have been submitted, no action is required. However, if the district wishes the data in the rejected record to be loaded to the data base, the Survey Period Code must be corrected either on the records coming in or the transmission JCL and all records must be resubmitted in a batch transaction or added on-line.

2. **District Number, Current Enrollment must be numeric and in the range 01-69, or 71-75 and must be correct for the district submitting the data. -record rejected-**

EXAMPLE

The first two records listed below would be loaded to the data base assuming no other reject rule would cause their rejection. The third record (indicated by an asterisk) would be rejected since the District Number, Current Enrollment is not in the appropriate range.

DISTRICT RESPONSIBILITY

If the rejected record should not have been submitted, no action is required. However, if the district wishes the data in the rejected record to be loaded to the data base, the district must correct the District Number, Current Enrollment and resubmit the record.

STUDENT COURSE SCHEDULE - REJECT RULES

7. If Survey Period Code is 1, then

- School Number, Current Instruction/Service must be numeric in the range 0001-9899 (excluding 9001), 9996, or
- it must be C901-C928, U970-U980, or P001-P999.

If Survey Period Code = 2 or 3, then

- School Number, Current Instruction/Service must be numeric in the range 0001-9899 (excluding 9001), 9996, C901-C928, U970-U980, P001-P999, or
- it may be a private school number.

If Survey Period Code is 4, then

- School Number, Current Instruction/Service must be numeric in the range 0001-9899 (excluding 9001), 9996, , or
- it must be C901-C928, U970-U980, or P001-P999.
-record rejected-

NOTE: If School Number, Current Instruction/Service is a private school number, Course Number must be 2222222.

EXAMPLE

The records listed below would be rejected because in each case the School Number, Current/Instruction Service is not within the valid range.

DISTRICT RESPONSIBILITY

If the rejected records should not have been submitted, no action is required. However, if the district wishes the data in the rejected records to be loaded to the data base, the district must correct the School Number, Current Instruction/Service and resubmit the records.

STUDENT COURSE SCHEDULE - REJECT RULES

53. If Course Number begins with a number; and

- is a course number from the Career and Technical Education/Adult General Education Program Edit file (F61730); and
- is not 1006300, 2001310, 2001340, 2003310, 2102360, 2102370, 3027010, 3027020, 2000350 or 2000360 with an FEFP Program Number other than 300;
- then the Career and Technical Education/Adult General Education Program Code must be a valid program number for the Course Number submitted, as listed in file F61730.

If Course Number begins with alphabetic characters followed by a zero in the fourth position, and

- is a course number from the Career and Technical Education/Adult General Education Program Edit file (F61730);
- then the Career and Technical Education/Adult General Education Program Code must be a valid program number for the Course Number submitted, as listed in file F61730. –record rejected-

EXAMPLE

The first and second records listed below would be loaded to the data base assuming no other reject rule would cause their rejection. The third record would be rejected because the Vocational/Adult General Education Program Code is not a valid program number.

DISTRICT RESPONSIBILITY

If the rejected record should not have been submitted, no action is required. However, if the district wishes the data in the rejected record to be loaded to the data base, the district must correct the Career and Technical Education/Adult General Education Program Code and resubmit the record.

STUDENT COURSE SCHEDULE – VALIDATION/NULL EDIT RULES

62. If Survey Period Code is 1, 2 or 3 then

- a student's total FTE Earned, Course during any one survey for a District Number, Current Instruction/Service may not exceed 0.5000 excluding FTE Earned, Course for those courses with the Year-Round/Extended School Year FTE Indicator set to "A" or "B".



If Survey Period Code is 4 and no Student Course Schedule record for the Student Number Identifier, Florida has

- a School Number, Current Instruction/Service of 7001, 7006, 7004, or 7023, or
- , a School Number, Current Instruction/Service of 0300 or 0400 with a District Number, Current Instruction/Service of 71, or
- A School Number, Current Instruction/Service of 0500 with a District Number, Current Instruction/Service of 71 and a Grade Level of 04 or 05,

then, the student's total FTE Earned, Course for the District Number, Current Instruction/Service may not exceed 0.5000 excluding FTE Earned, Course for those courses with the Year-Round/Extended School Year FTE Indicator set to "A" or "B".

-state validation/NULL-

Note: FTE Earned is attributed to the school of instruction unless the school of instruction is a college, university or non-public school in which case the FTE Earned is attributed to the school of enrollment.

EXAMPLE

The FTE Earned, Course would be set to NULL at the end of the State Records Processing Cycle on ALL the Student Course Schedule records listed below because the student's total FTE Earned, Course in the district of instruction for the survey exceeds 0.5000.

DISTRICT RESPONSIBILITY

The district must correct the Student Course Schedule records so that the student's total FTE Earned, Course does not exceed 0.5000.
