If the School Number Current Instruction/Service does not begin with "P" then the Course Number must not begin with 00. -record rejected-

Note: Local use only transfer course numbers for Grade Levels 09-12 are <u>numeric</u> course numbers that end in 980 or 990. Local use only transfer course numbers for Grade Levels 30-31 are <u>alphanumeric</u> course numbers that begin with one alpha character and end with six zeroes.

The third record listed below would be loaded to the data base assuming no other reject rule would cause its rejection. The first and second records would be rejected because the Course Numbers are local use only transfer course numbers.
