If the rejected records should not have been submitted, no action is required. However, if the district wishes the data in the rejected records to be loaded to the data base, the district must correct the School Number, Current Instruction/Service and resubmit the records.

3. Survey Period Code must be 5 and must be correct for the submission specified by the district. -record rejected-

EXAMPLE
