No industry certification was attempted by the student in the course being reported.</td> </tr> </table> <p>*For certifications or assessments with more than one exam, an industry certification identifier should only be reported when all exams required to earn the certification or pass the assessment have been taken/attempted.</p> <p>→ For example, MICRO069 - This Microsoft bundle requires that a student pass three of five exams. Students must have taken at least three exams for the industry certification identifier to be reported.</p> <p>For certifications or assessments with work experience requirements, an industry certification identifier may be reported as an attempt when all exams have been taken and any requirements other than work experience are satisfied (i.e., report valid identifier on Industry Certification Identifier element and outcome of "F" on the Industry Certification Outcome element).</p> <p>For example, NRAEF002 - This certification requires the student pass Year 1 and Year 2 exams and complete 400 hours of work experience.
