## STUDENT COURSE SCHEDULE - REJECT RULES

53. If Course Number begins with a number; and
- is a course number from the Career and Technical Education/Adult General Education Program Edit file (F61730); and
  - is not 1006300, 2001310, 2001340, 2003310, 2102360, 2102365, 2102370, 3027010, 3027020, 2000350 or 2000360 with an FEFP Program Number other than 300;
  - then the Career and Technical Education/Adult General Education Program Code must be a valid program number for the Course Number submitted, as listed in file F61730.

If Course Number begins with three alphabetic characters followed by a zero in the fourth position, and

- is a course number from the Career and Technical Education/Adult General Education Program Edit file (F61730);
- then the Career and Technical Education/Adult General Education Program Code must be a valid program number for the Course Number submitted, as listed in file F61730.

If Course Number begins with one alphabetic character, and

- is a course number from the Career and Technical Education/Adult General Education Program Edit file (F61730);
- then the Career and Technical Education/Adult General Education Program Code must be the same as the Course Number.

### EXAMPLE

The first and second records listed below would be loaded to the data base assuming no other reject rule would cause their rejection. The third record would be rejected because the Vocational/Adult General Education Program Code is not a valid program number.

## STUDENT DEMOGRAPHIC – REJECT RULES

 39. If Residence County code is 99 and Grade Level is PK-12, then Resident Status, State/County code must be 0 or 2. (This edit does not apply to Survey Periods 6 and 8.) -record rejected-

### EXAMPLE

The first and second records below would be rejected because the Resident Status, State/County code is invalid for the Residence County code reported. The third record would be written to the data base assuming no other reject rule would cause its rejection.

Student Number Identifier, Florida	Residence County	Resident Status, State/County

### DISTRICT RESPONSIBILITY

If the rejected records should not have been submitted, no action is required. However, if the district wishes the data in the rejected records to be loaded to the data base, the district must correct the Residence County codes or the Resident Status, State/County codes and resubmit the records.

## STAFF PAYROLL INFORMATION - STATE VALIDATION RULES

### NEW EDIT FOR 1516:

54. If Employment Date, Original Position on the Staff Demographic record is prior to 07012011, then Salary Schedule Pay Type must equal 1-7 or A.

If Employment Date, Original Position on the Staff Demographic record is on or after 07012014, or Employment Date, Current Position on the Staff Demographic record is on or after 07012014, then Salary Schedule Pay Type must equal B. *(Note: This applies where employee's Job Code line number of the Public Schools Staff Survey - EEO-5 changed from line 09-19 to 21-43, inclusive, or changed from line 21-43 to 09-19, inclusive, or changed from line 01-08 or 44-54 to 09-43, inclusive.)*

If Employment Date, Original Position on the Staff Demographic record is on or after 07012011, then Salary Schedule Pay Type must equal B (formerly Salary Schedule Pay Type 9)

The match should be based on District Number, Social Security Number, Fiscal Year and Survey Period Code. –state validation-

### EXAMPLE

The Staff Payroll record listed below would cause an error message to be generated because the Employment Date, Current Position on the Staff Demographic Information record is after July 1, 2011 (07012011) and the Salary Schedule Pay Type is 1.

### DISTRICT RESPONSIBILITY

The district must identify the invalid data on the Staff Payroll record or Staff Demographic record, then make the appropriate correction.
