TEACHER COURSE - STATE VALIDATIONS/NULL EDIT RULES

(New Edit for 1415)

→ 52. If Survey Period Code is 2 or 3, and if Period Number does not end in 88, then for all Teacher Course records that match on District Number, Current Instruction/Service; School Number, Current Instruction/Service; Fiscal Year; Survey Period Code; Classroom Identification (FISH) Number; Course Number; and Period Number and Scheduling Method equals C, the following conditions must be true:

- At least one Teacher Course record must have Certification/Licensure/Qualification Status equal to A, H, I, M, S or V
- At least one teacher in the group of Teacher Course records must have at least three years' experience on the Staff Experience format. Must match by District Number, SSN, Survey Period, Year
- Same teacher does not need to satisfy both conditions

-state validation-

EXAMPLE:

The below records would cause a validation error message to be generated because although the Certification/Licensure/Qualification Status is met, there must be at least one Staff Experience record where Experience Length is reported as three or more years for the team.

5D. If Survey Period Code is 2 or 3, and if Period Number does not end in 88 and if Scheduling Method equals I then for all Teacher Course records that match on District Number, Current Instruction/Service; School Number, Current Instruction/Service; Fiscal Year; Survey Period Code; Classroom Identification (FISH) Number; Course Number; and Period Number, the following conditions must be true:

- **At least one Teacher Course record must have Certification/Licensure/Qualification Status equal to A, H, I, M, S or V**
- **At least one teacher in the group of Teacher Course records must have at least three years' experience on the Staff Experience format. Must match by District Number, SSN, Survey Period, Year**
- **Same teacher does not need to satisfy both conditions**

-state validation-

EXAMPLE:

The records listed below would cause a validation error message to be generated because it does not have a matching Staff Experience record for at least one teacher on the team that meets the Experience Length of three or more years.

ENGLISH LANGUAGE LEARNERS INFORMATION - REJECT RULES

10. If Survey Period Code is 2 or 3, English Language Learners: Exit Date must be numeric and a valid date less than or equal to the survey date, unless zero-filled. If Survey Period Code is 5, English Language Learners: Exit Date must be numeric and a valid date less than or equal to June 30th unless zero filled. If Survey Period Code is 7, and if English Language Learners: Reclassification Date is zero, then English Language Learners: Exit Date must be numeric and a valid date between August 1 August 21 of the current school year and the last day of survey 7 processing or it must be zero filled. –reject record–

EXAMPLE

The first record listed below would be loaded to the data base assuming no other reject rule would cause its rejection. The second record would be rejected because Exit Date is not a valid date.

Student Number Identifier, Florida	ELL: Exit Date
123456789X	01192010
* 223456789X	02312010

DISTRICT RESPONSIBILITY

If the rejected record should not have been submitted, no action is required. However, if the district wishes the data in the rejected record to be loaded to the data base, the district must correct the ELL: Exit Date and resubmit the record.
