The current House and Senate budget proposals include a reduction in base funding to districts based on the 2009-10 instructional hours in the co-enrolled adult high school program. Attached is a summary of the 2009-10 FTE for each district with a co-enrollment program.

In addition, both the House and the Senate would amend Florida Statutes in the following bills:

Amends Section 1011.80, Florida Statutes, and includes the following language: "A student who is coenrolled in a K-12 education program and an adult education program may not be reported for funding in an adult education program."

Amends Section 1011.80, Florida Statutes, and includes the following language: "A student who is coenrolled in a K-12 education program and an adult education program may not be reported for funding in an adult education program."

Senate Bill 2120: <http://www.flsenate.gov/Session/Bill/2011/2120>

Amends Section 1004.02, Florida Statutes, as follows: "(6) "Adult student" is a student who is beyond the compulsory school age and who has legally left elementary or secondary school, ~~or a high school student who is taking an adult course required for high school graduation.~~"
