## **Student Performance Data**

The assessment data in the Florida Comprehensive Assessment Test (FCAT) and Florida Alternate Assessment (FAA) tables described below were derived using data from the Florida Department of Education, Bureau of Evaluation and Reporting as of August 2011. Participation data are calculated using all enrolled students. Proficiency data are calculated for all students who are enrolled for a full academic year in a given district (reported in both October and February surveys).

### ***Statewide FCAT Participation and Performance 2008-09 through 2010-11***

The charts on pages 3-10 reflect statewide participation and performance in reading and math for students with disabilities taking the FCAT in 2008-09 through 2009-10 and those taking FCAT 2.0 in 2010-11. The chart includes the percentage of students with disabilities participating in the FCAT or FCAT 2.0 and the percentage of these students scoring at level 3 or higher on the assessment. The data are presented for students in grades 3-5, grades 6-8, grades 9-10, and grades 3-10. Because ninth grade FCAT math was replaced by end of course assessments in 2010-11, the table on page 10 does not include grade 9.

### ***Statewide FAA Participation and Performance, 2008-09 through 2010-11***

These charts, pages 11-18, show statewide participation and performance in reading and math for students with disabilities taking the FAA Assessment in 2008-09 through 2010-11. The chart includes the percentage of students with disabilities participating in the FAA and the percentage of these students scoring at level 4 or higher. The data are presented for students in grades 3-5, grades 6-8, grades 9-10 and grades 3-10. Because there was no ninth grade FCAT math administered in 2010-11, a participation rate could not be calculated for the FAA.

### ***FCAT and FAA 2010 Reading and Mathematics Participation and Performance***

These tables (pages 19-54) present district level data for the 2011 administration of FCAT and FAA for grades 3-10 in reading and math. The table displays separately the number and percentage of students with disabilities participating in the (1) FCAT with accommodations, (2) FCAT without accommodations, and (3) FAA as well as the percent of students reported as proficient and higher. Districts are organized by enrollment group within the tables and percentages are rounded to the nearest whole number. Because the FCAT math was not administered to ninth graders in 2010-11 the table for grade 9 includes only alternate assessment data.

***Participation in Alternate Assessment 2011 by Primary Exceptionality***

The graph on page 55 shows the distribution of students with disabilities participating in the FAA. The tables on pages 56-59 show the number of students by district and primary exceptionality taking the FAA during 2010-11.

***Preschool Outcomes, 2009-10***

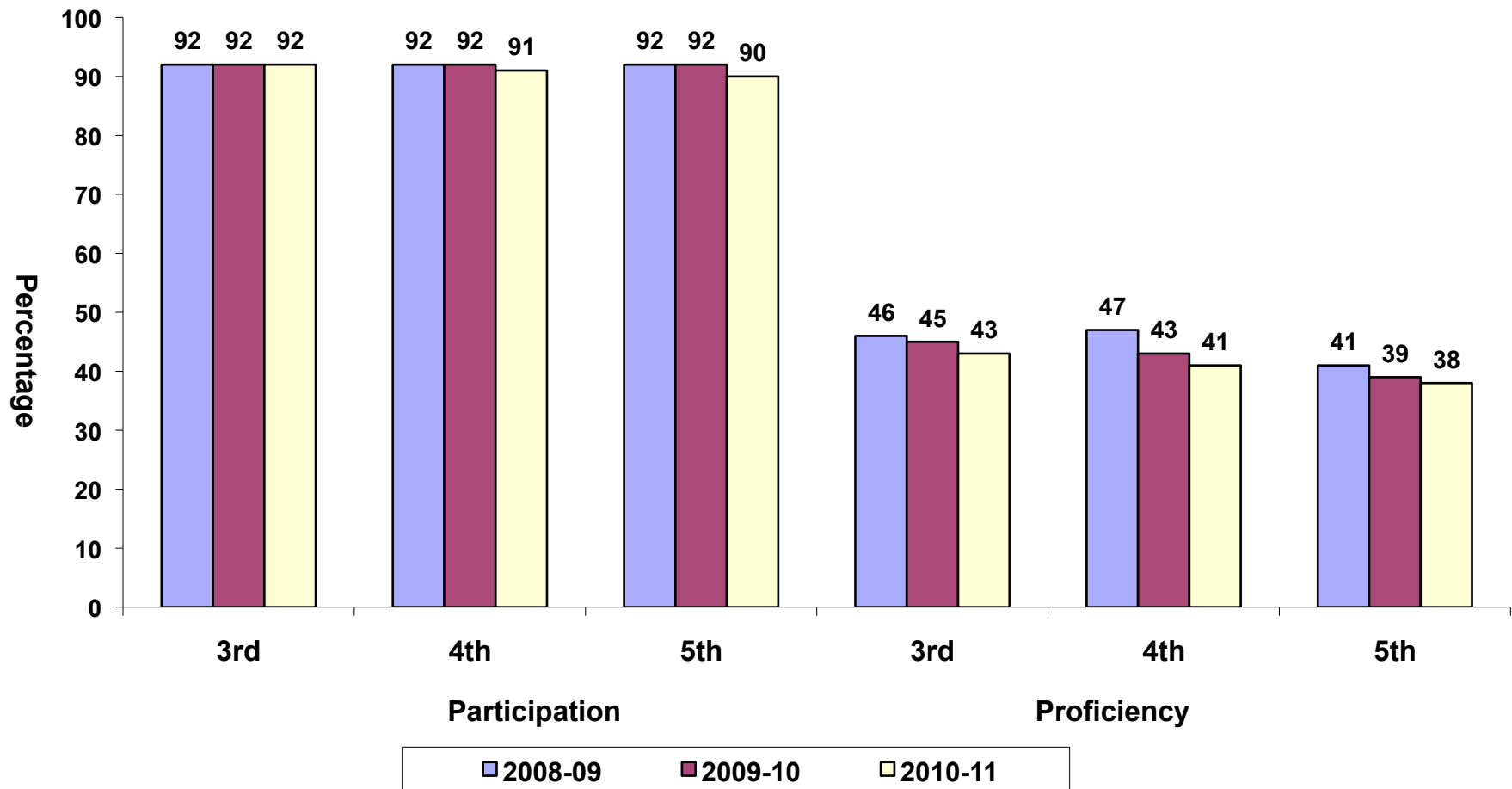
The table on pages 60-61 shows the percentage of prekindergarten children with disabilities who entered prekindergarten below age expectations, but substantially increased their rate of growth by the time they exited the preschool program as measured by the Battelle Developmental Inventory-2 (BDI-2).

Percentages are shown for each of three domains: Personal-Social, Communication, and Adaptive. The table includes those children who exited the preschool program during the 2009-10 school year. In order to be included, the students had to have valid entry and exit assessment scores for all three domains.

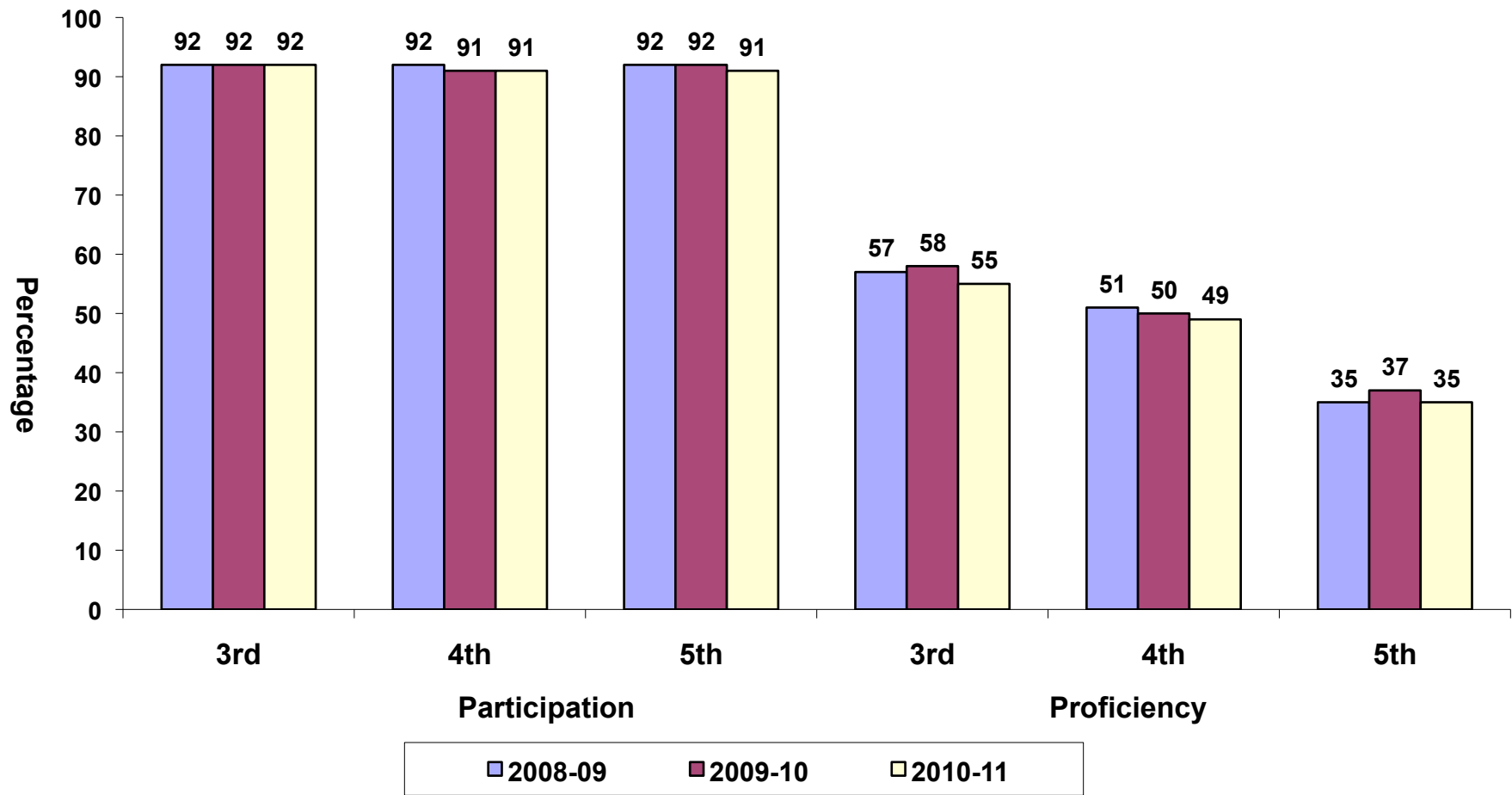
The table on pages 62-63 shows the percentage of prekindergarten children with disabilities who were functioning within age expectations by the time they exited the preschool program, as measured by the BDI-2. Percentages are shown for each of three domains: Personal-Social, Communication, and Adaptive. The table includes those children who exited the preschool program during the 2009-10 school year. In order to be included, the students had to have valid entry and exit assessment scores for all three domains.



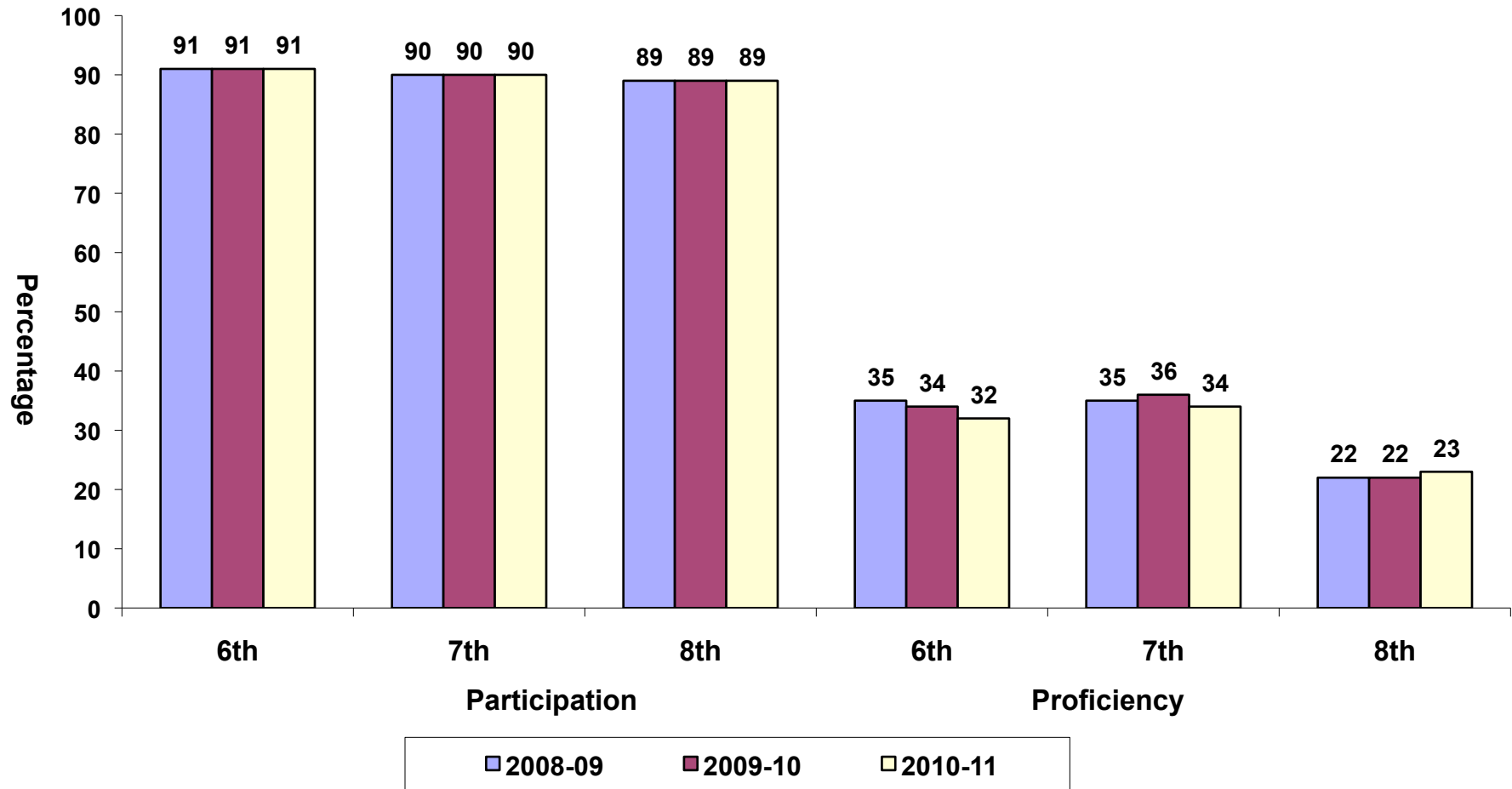
# **FCAT Reading Participation and Performance Students with Disabilities Grades 3-5 2008-09 through 2010-11**



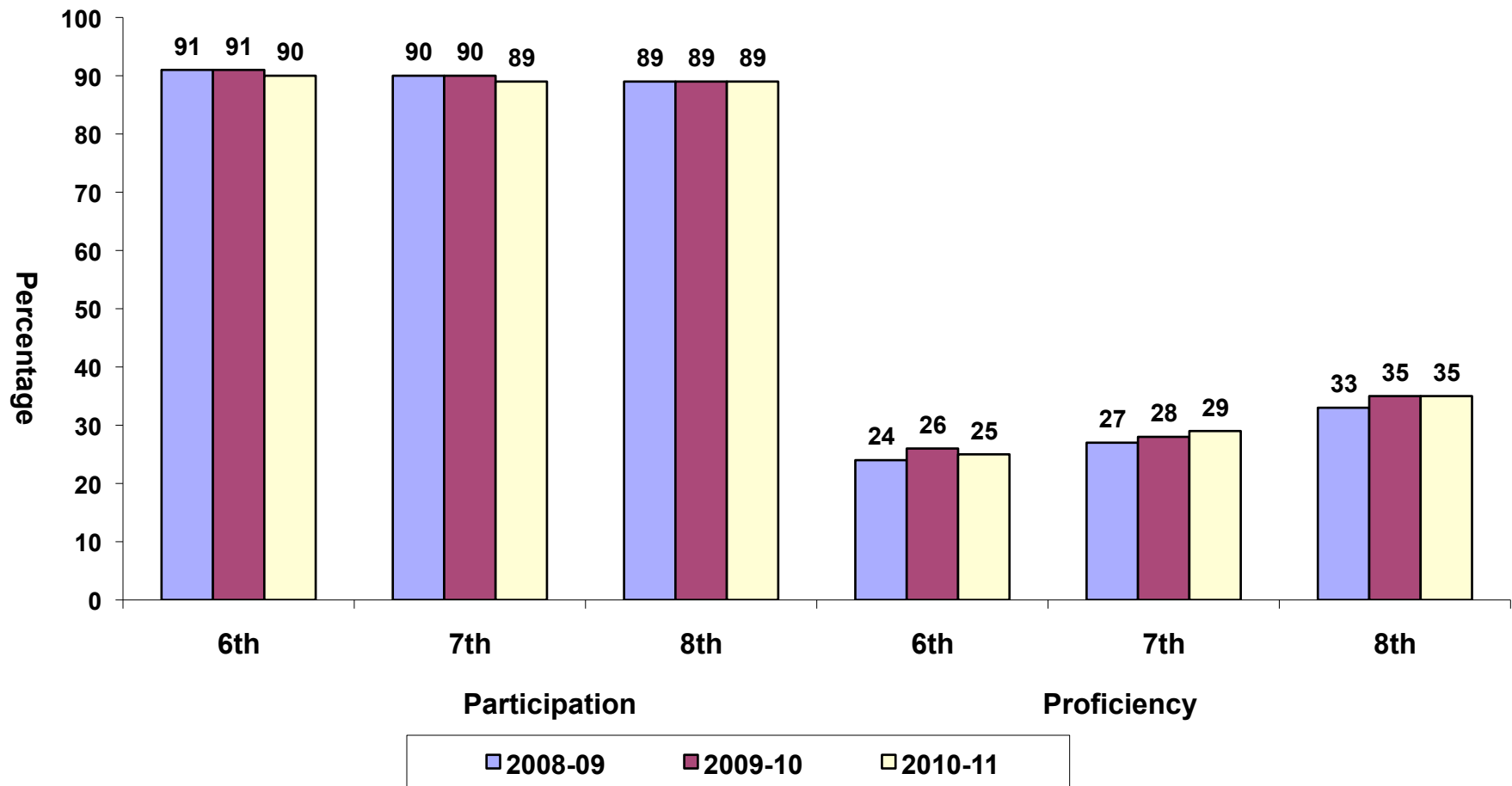
**FCAT Math Participation and Performance

2008-09 through 2010-11**



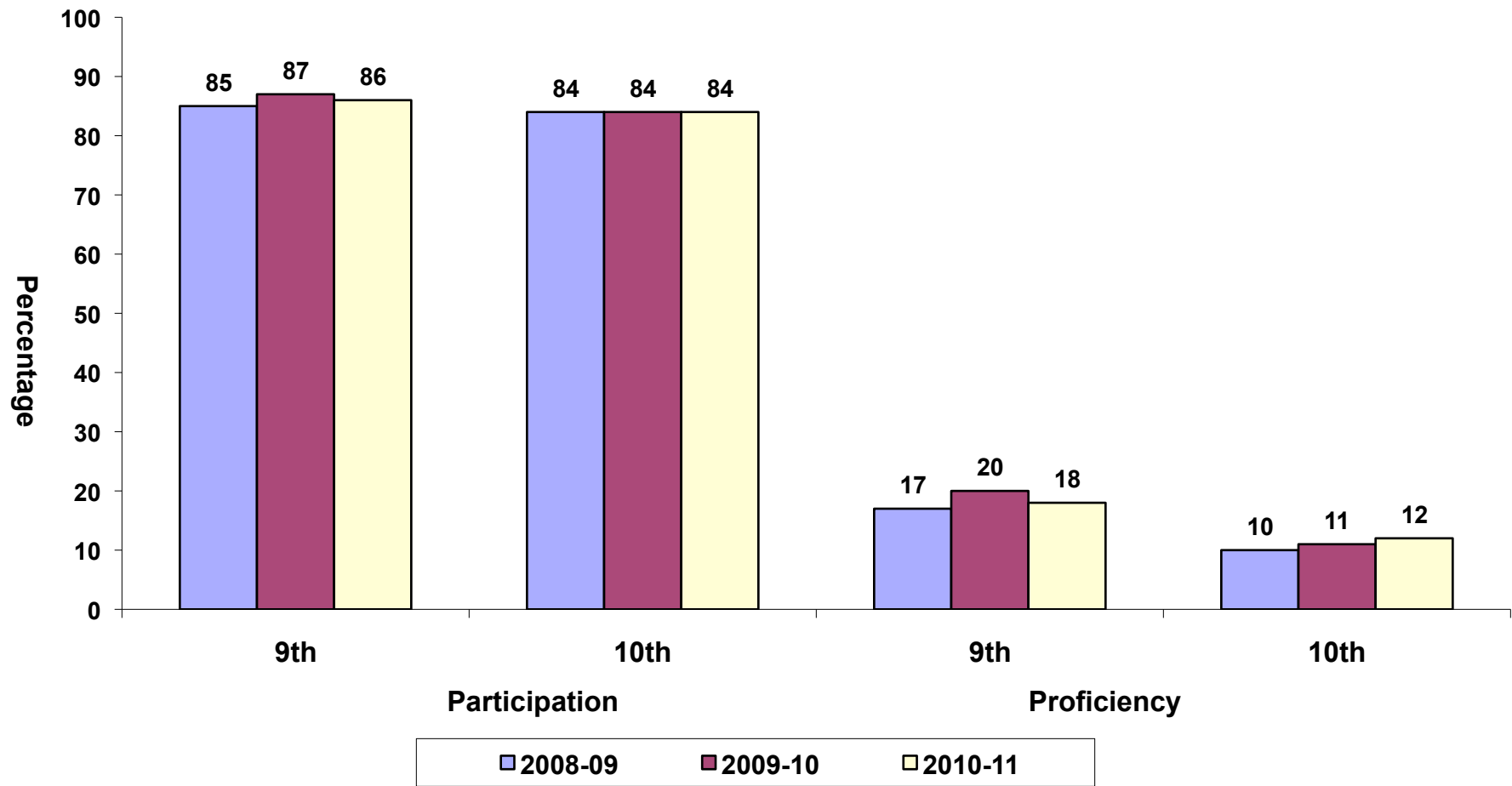
# **FCAT Reading Participation and Performance Students with Disabilities Grades 6-8 2008-09 through 2010-11**



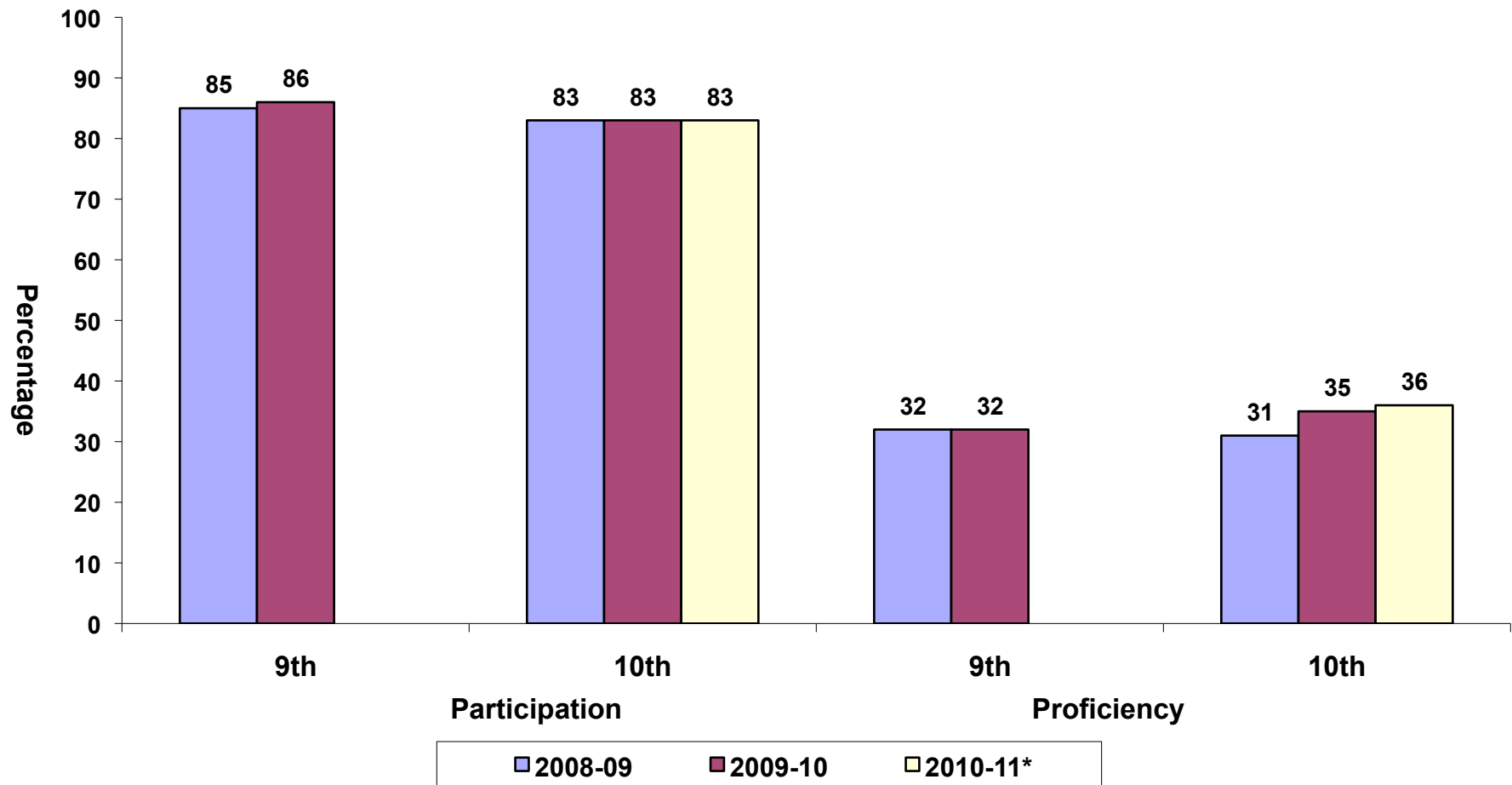
# **FCAT Math Participation and Performance Students with Disabilities Grades 6-8 2008-09 through 2010-11**

2008-09 through 2010-11**

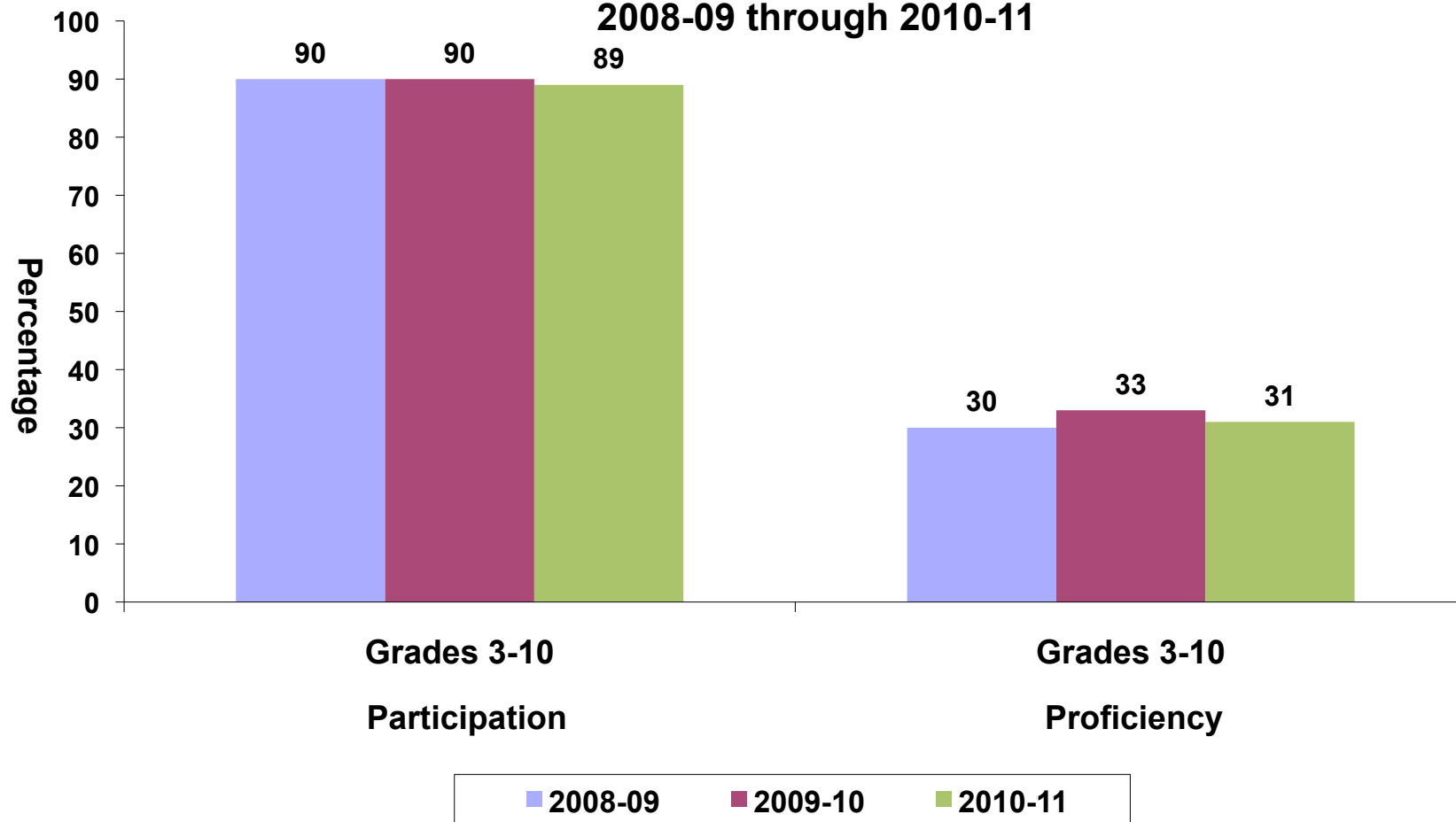


# **FCAT Math Participation and Performance Students with Disabilities Grades 9-10 2008-09 through 2010-11**

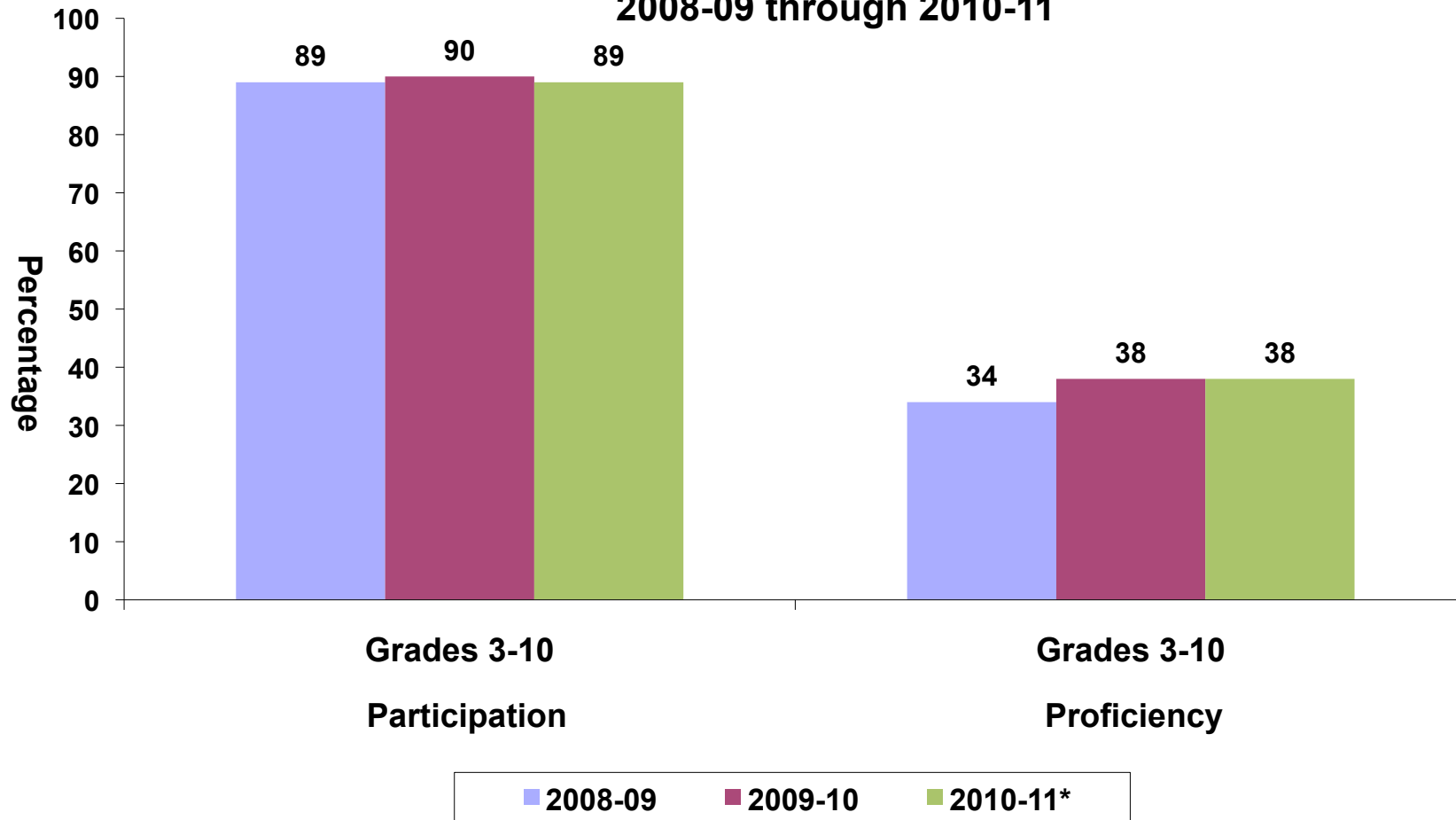

2008-09 through 2010-11**



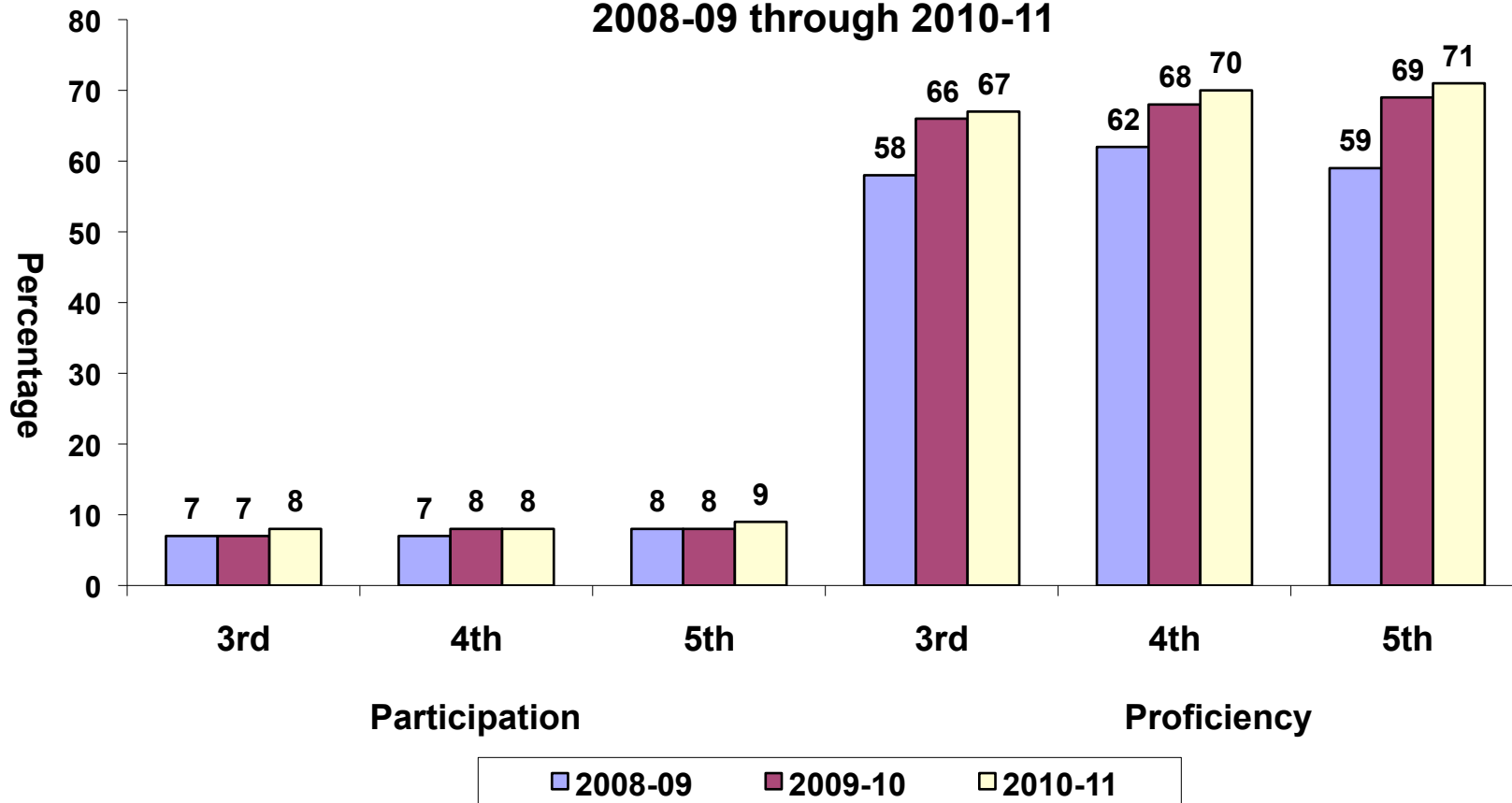
**FCAT Math Participation and Performance

2008-09 through 2010-11**



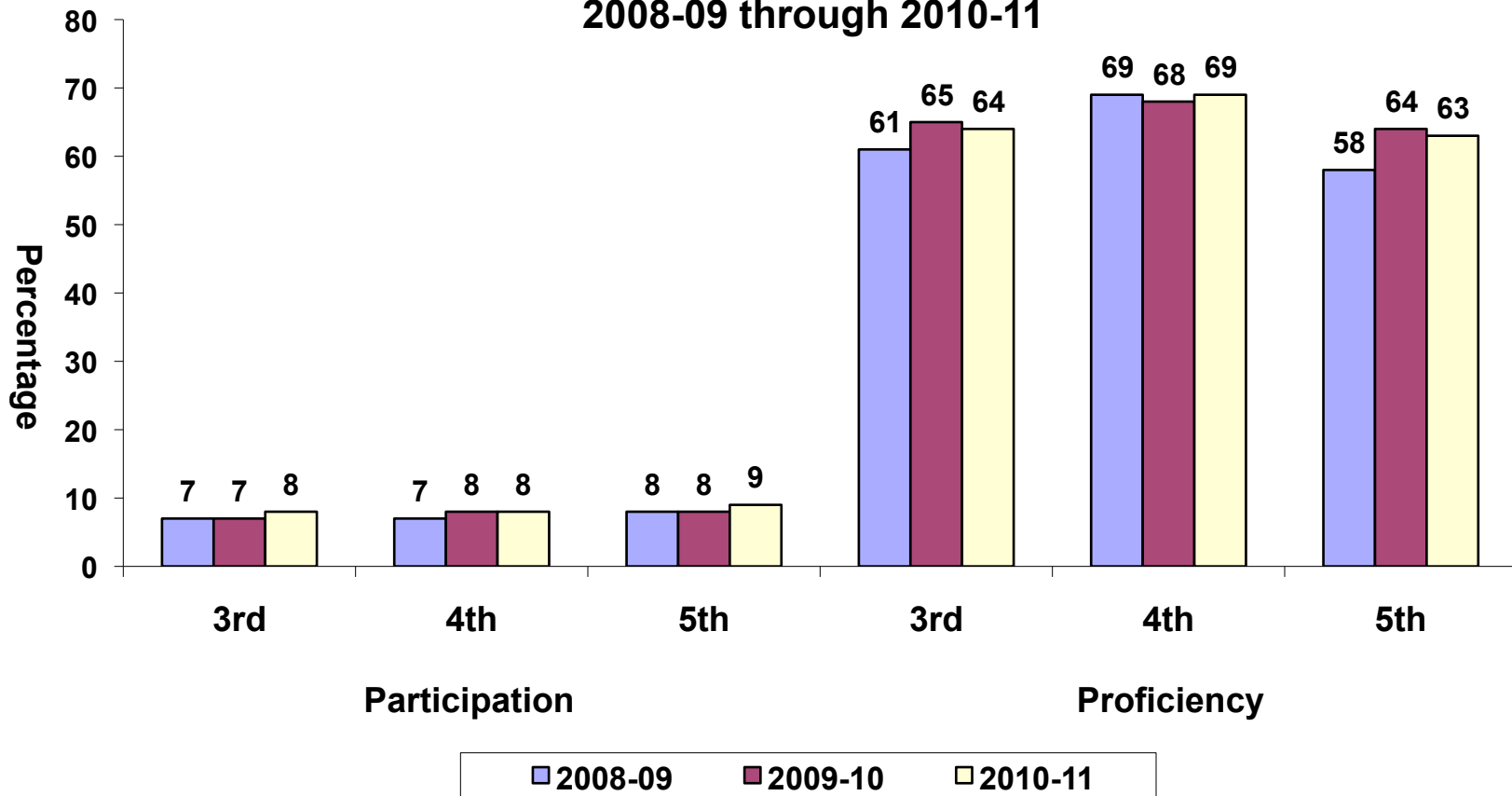

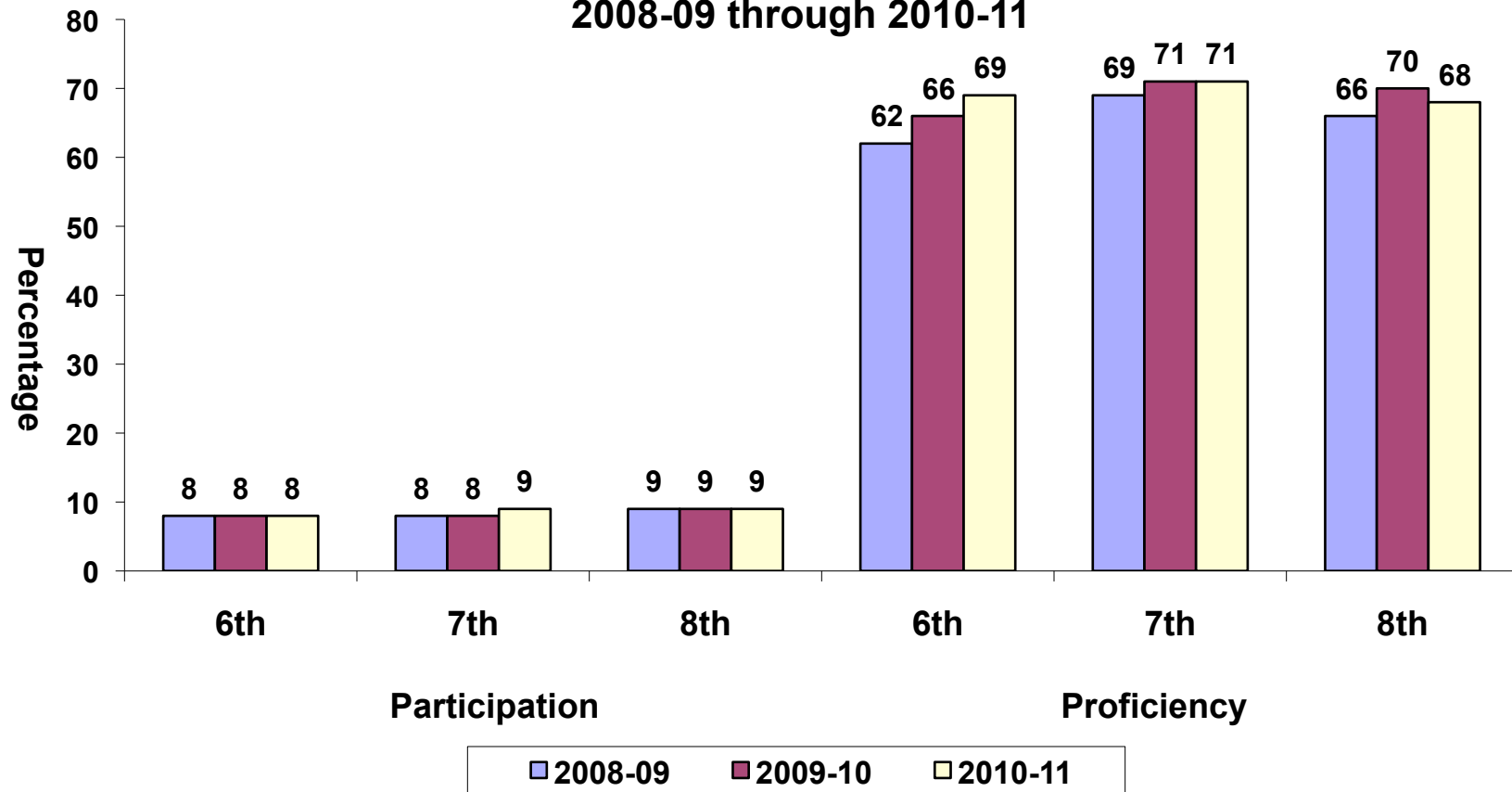
**Florida Alternate Assessment

2008-09 through 2010-11**



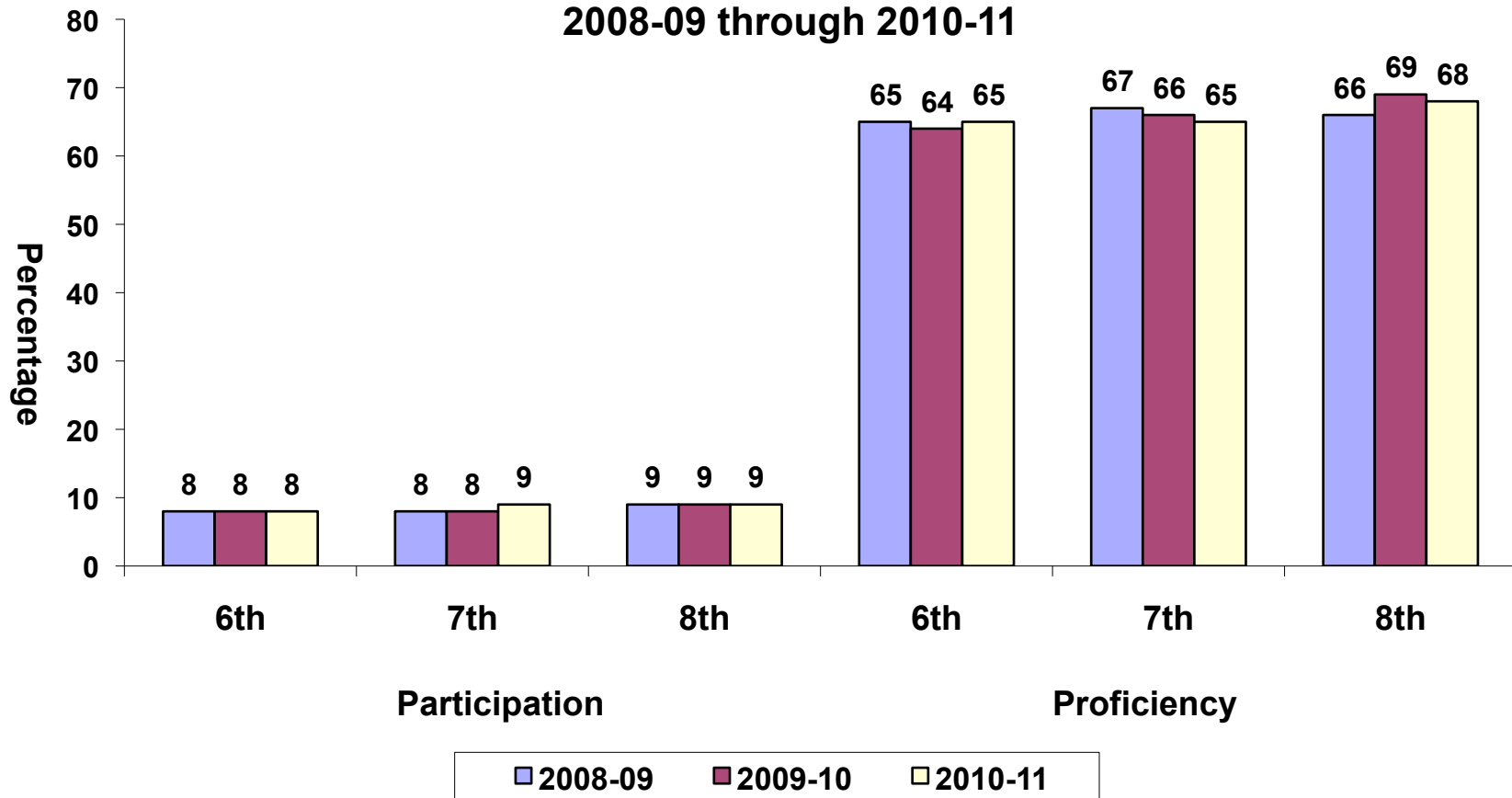
**Florida Alternate Assessment

2008-09 through 2010-11**



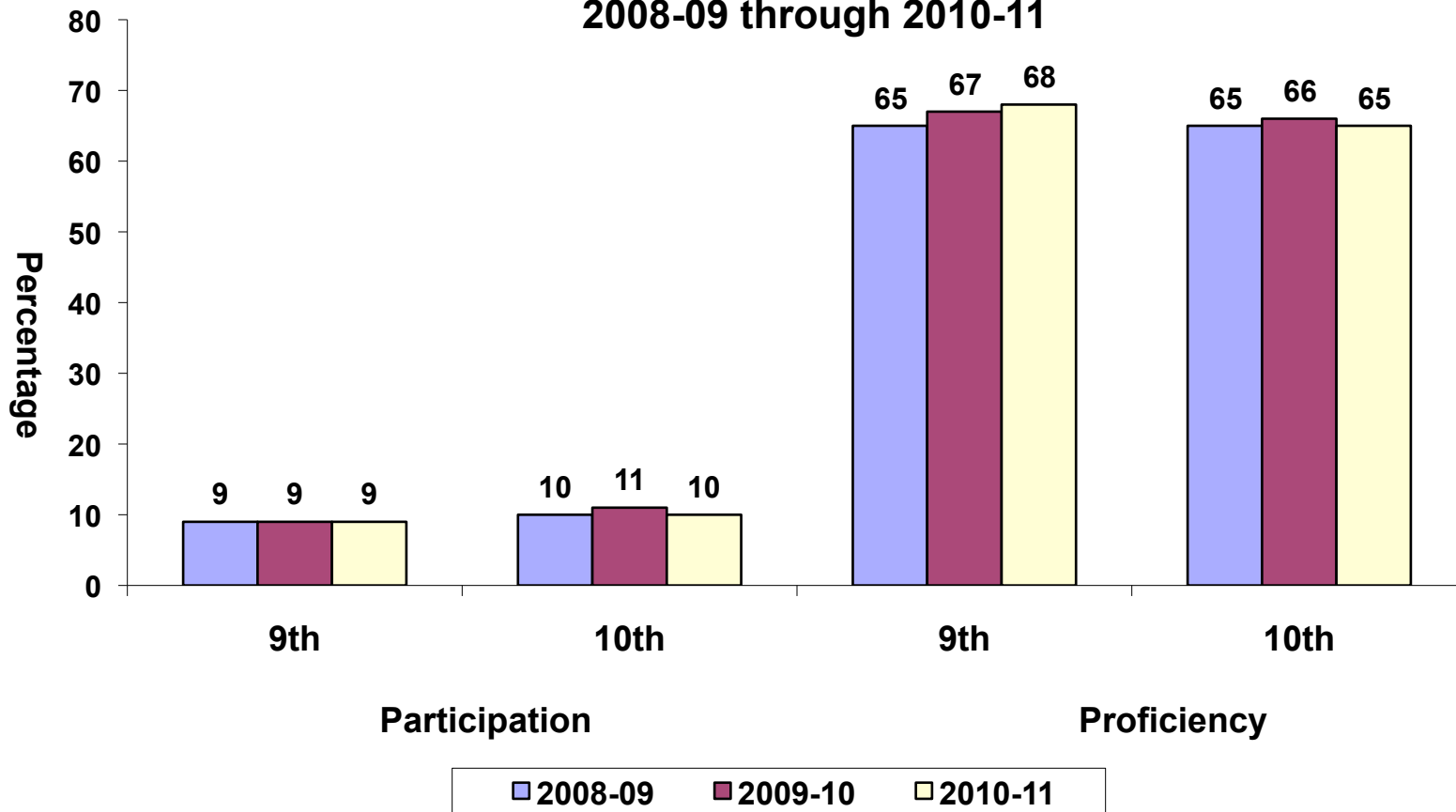
**Florida Alternate Assessment

2008-09 through 2010-11**



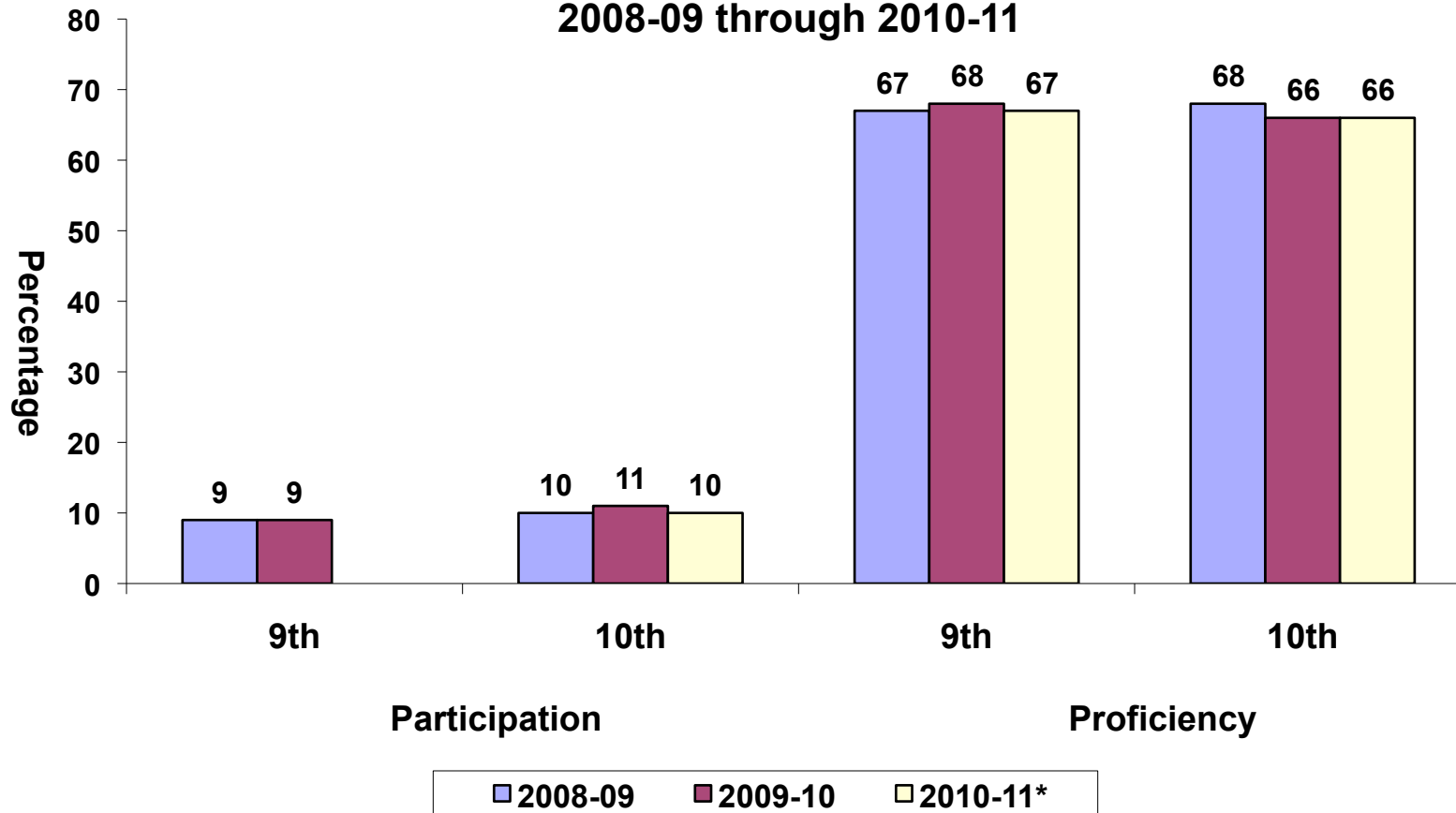

2008-09 through 2010-11**

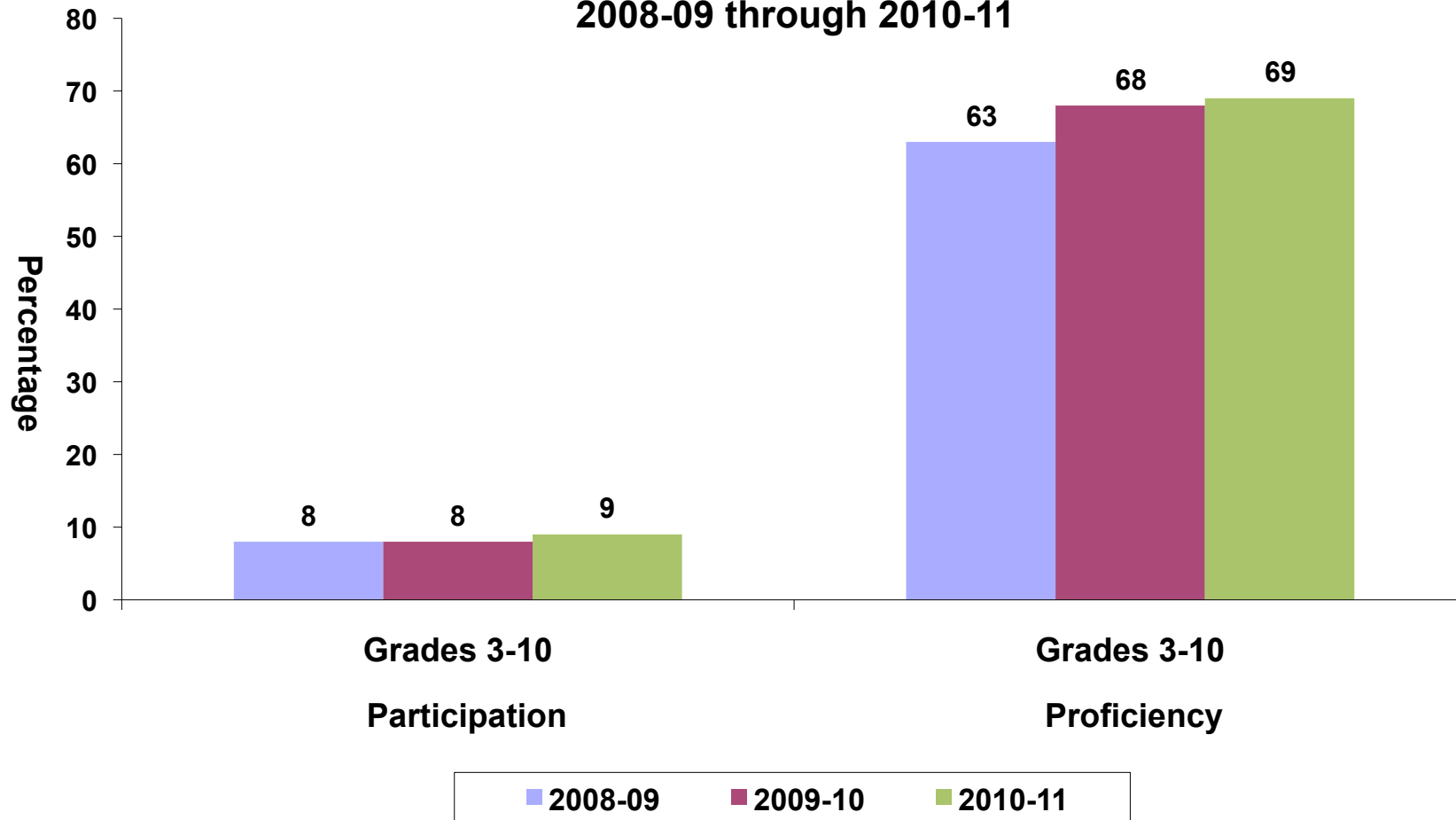

2008-09 through 2010-11**

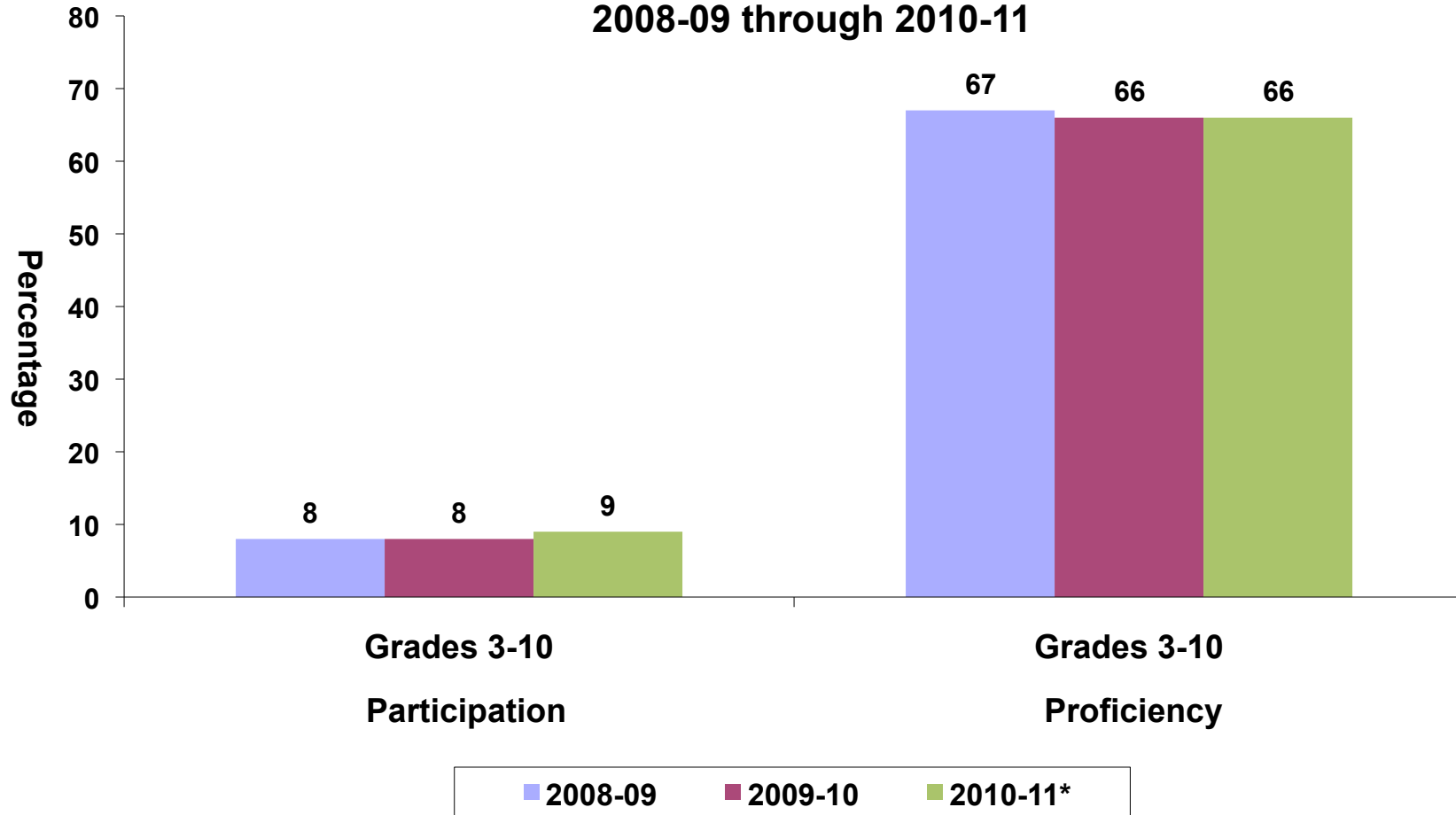

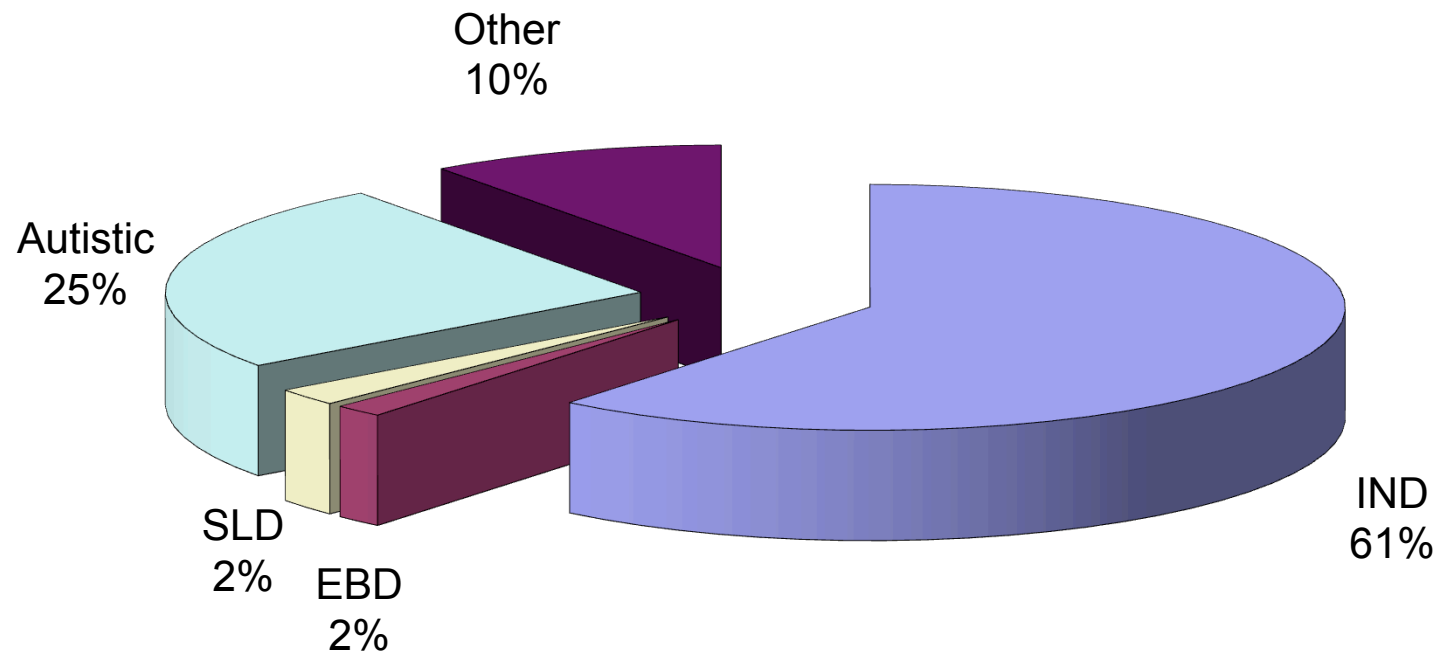

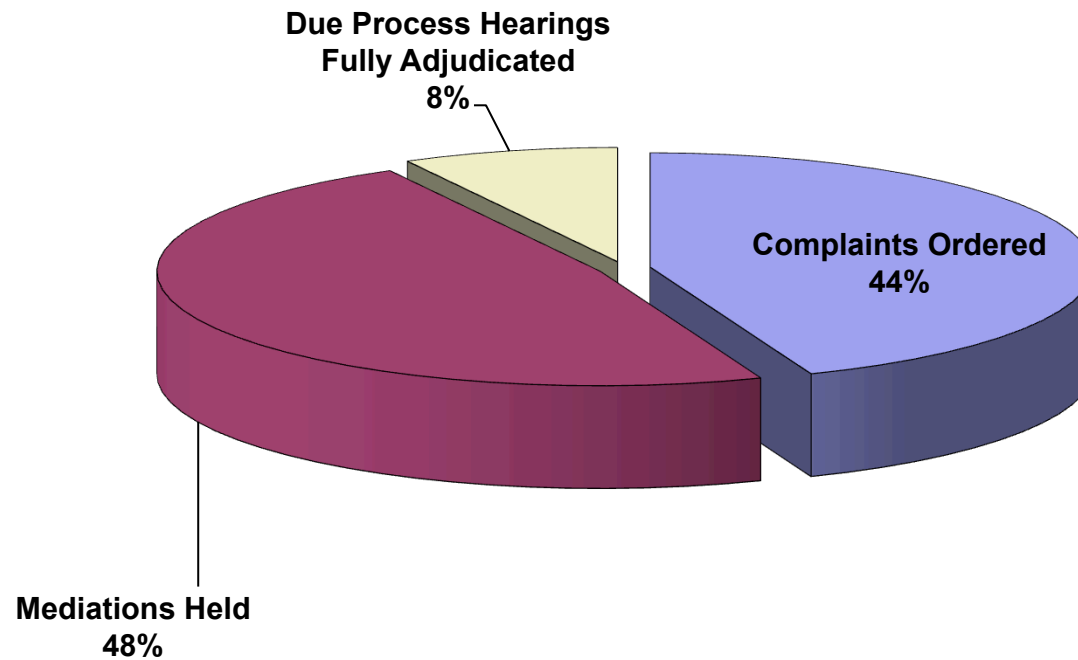

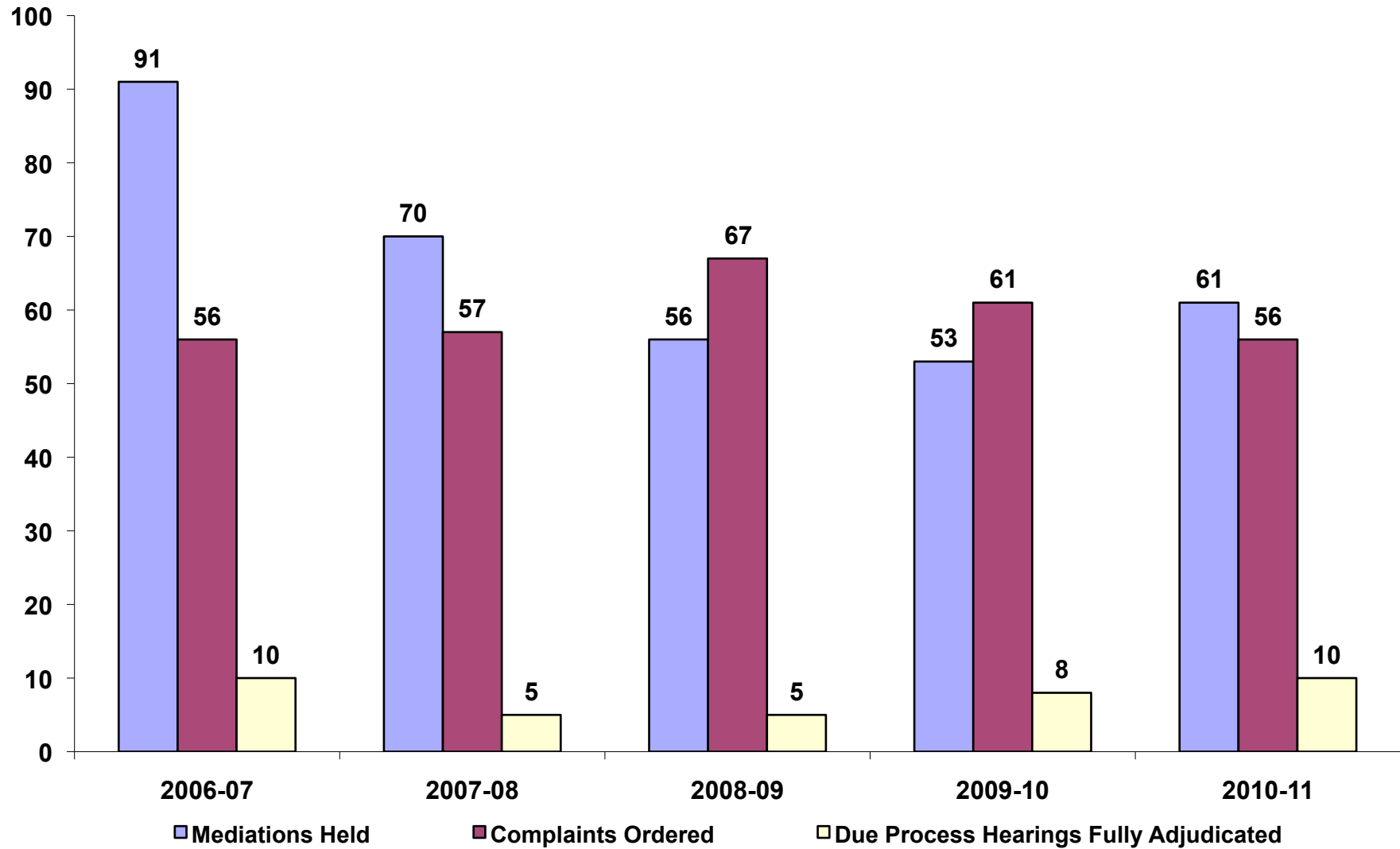
**Dispute Resolution Summary**
