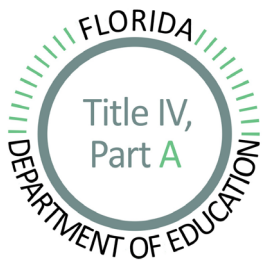

## Tinkercad 3D Modeling

Learn the basics of designing for Virtual Reality and the Merge Cube (Augmented Reality) using CoSpaces. In this training you will learn the basics of CoSpaces and explore tools and techniques for building lessons that will have your students designing virtual worlds, animating, and coding. A discussion on how to use this software for remote learning will be included. This class is appropriate for classroom teachers of all areas who are just beginning working in CoSpaces.

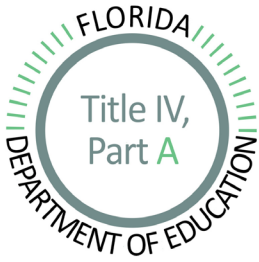
