#### From Commissioner Robinson...

During the State Board of Education meeting on February 28, 2012, in Tallahassee, the board voted to create a taskforce to develop an implementation plan to include students with disabilities, students who are learning the English language, and students enrolled in exceptional student education centers in Florida's school accountability system and to create recommendations for consideration by the U.S. Department of Education regarding Florida's Elementary and Secondary Education Act (ESEA) flexibility waiver.

Commissioner Robinson outlined four goals for the taskforce:

- 1. Identify best practices to ensure Florida leads the nation in fully including students with disabilities, students who are learning the English language, and students enrolled in exceptional student education (ESE) centers.
- 2. Identify strategies to reduce unintended consequences of including students with disabilities, students who are learning the English language, and students enrolled in ESE centers.
- Identify potential enhancements to Florida's school grade rule regarding the inclusion of students with disabilities, students who are learning the English language, and students enrolled in ESE centers that are consistent with the conditions of the federal ESEA flexibility waiver.
- 4. Identify recommendations and strategies to discuss/negotiate with the U.S. Department of Education to inform future federal policy.

#### A Once-in-a-Lifetime Experience for Teachers

Middle and high school teachers from throughout Florida experienced the state courts firsthand during the 2012 Florida Supreme Court Justice Teaching Institute. Twenty-six middle and high school teachers from 17 of Florida's 20 judicial circuits were selected to participate in a four-and-a-half day program designed to prepare teachers to accurately and effectively teach about the state courts and the judicial branch. All seven justices served as faculty for the institute which was held in the Florida Supreme Court. The program is administered by The Florida Law Related Education Association, Inc., and funded in part by the Florida Bar Foundation.

The 2012 program utilized a case study approach to teach about the state courts and the appellate process. Teachers explored the Fourth Amendment, the structure and function of the courts, the Florida Constitution, and judicial decision-making and accountability. Each justice presented one or more sessions as well as interacted with the teachers throughout the week at lunch or dinner events.

"This was the most amazing experience of my life," stated Brian Firtell, a seventh grade civics teacher in the Miami-Dade Public Schools. "In my 26 years of teaching, nothing has come close to this once-in-a-lifetime opportunity!"

The institute began with a mock oral argument exercise to provide teachers with a simulation that could be used when they returned to the classroom to teach about the appellate process. Justice R. Fred Lewis and Annette Boyd Pitts, Executive Director of the Florida Law Related Education Association, Inc., facilitated the experience. At the conclusion of the week, teachers observed the real case argued before the Supreme Court.



The most important factor in the achievement of our students is the effectiveness of the teachers and principals who serve them. The <u>Bureau of Educator Recruitment</u>, <u>Development and Retention</u> is committed to supporting and improving educator quality by providing assistance to educators, potential educators and school district staff in the following areas:

Recruitment provides information for job seekers for Florida schools, coordinates Florida's teacher recruitment website (TeachinFlorida.com), hosts the Great Florida Teach-In job fair, manages Florida Future Educators of America, and administers grant programs to increase the number of teachers with diverse backgrounds.

<u>Professional Development & Evaluation Systems</u> focuses on protocol reviews (feedback to districts on improving district professional development systems), assists districts in developing instructional and administrative evaluation systems, provides capacity-building web-based learning tools and resources for teachers and school leaders, administers the W.C. Golden School Leadership Development Program, and coordinates statewide professional learning supports with partner organizations.

Educator Preparation has the responsibility of reviewing and approving initial teacher preparation programs and Educator Preparation Institutes, which are offered statewide by public and private universities and colleges, and lead to certification to teach in Florida's public schools. This unit also oversees the state approval of Educational Leadership programs for those seeking careers in school administration or principalship.

<u>Title II. Part A</u>, Teachers and Principals Training and Recruiting Fund, provides grants to state educational agencies, local educational agencies, state agencies for higher education and eligible partnerships in order to increase student academic achievement through strategies such as improving teacher and principal quality and increasing the number of highly qualified teachers in the classroom and highly qualified principals and assistant principals in schools.

Recognition honors the contributions of outstanding school administrators, classroom teachers, and education support personnel through the coordination of the Florida Teacher of the Year Program, Florida School-Related Employee of the Year Program, Principal Achievement Award for Outstanding Leadership Program, and Outstanding Assistant Principal Achievement Award.

The <u>Dale Hickam Excellent Teaching Program</u> was established to provide incentives for qualified Florida educators to pursue excellence by obtaining advanced certification through the National Board for Professional Teaching Standards. National Board Certification is achieved upon successful completion of a voluntary assessment program designed to recognize effective and accomplished teachers who meet high standards based on what teachers should know and be able to do.

#### **CPALMS**

CPALMS, also known as FloridaStandards.org, is a collaborative, interdisciplinary project being built upon requests from Florida's educators. CPALMS aims to organize efforts to support educators working together toward goals of understanding and implementing standards. CPALMS is not only the official source of Florida's Standards, including Common Core State Standards (CCSS), and



Courses, with a collection of some of the best educational resources, and tools to help educators develop and use those resources; it is a community of educators. The CPALMS community is growing, with over 27 million visitors and more than 26,000 registered users. Registered users have built and shared more than 4,400 resources using the CPALMS tools. Resources include course plans, units, lessons, simulations, activities, professional development, and more from some of the best sources, including Florida's teachers. All resources that are shared through CPALMS are reviewed by peer teachers and content-area experts using a criteria-based feedback system, with the aim of providing constructive feedback toward high-quality lessons and resource integration. The review process ensures CPALMS resources are aligned with standards, include accurate and appropriate content, and utilize research-based approaches to instruction.

CPALMS already has excellent coverage of resources for the Next Generation Sunshine State Standards for mathematics and science, and resources for the CCSS for Mathematics and English Language Arts are now under review. This spring, the CPALMS community is launching several initiatives to support understanding and implementing the CCSS. Initiatives toward understanding the standards will include "unpacking" the standards to analyze what students are expected to know and be able to do, what common misconceptions students have related to standards, and what research tells us about how students learn the content and skills in the standards. The cognitive complexity of the standards will be determined to help educators align their instruction and assessment with the cognitive complexity expected of the standards. Standards progressions will be developed in a web-based and interactive map. Initiatives toward implementing standards include development of lesson study toolkits to maximize the benefits of and support school-based implementation of lesson study, and development of resource collections with innovative and integrated approaches to standards-based instruction and assessment. The most exciting development for CPALMS - iCPALMS - is coming this summer. The individualized CPALMS portal will take full advantage of individual interests to bring standards information, resources, and professional development to educators in a customizable portal with apps designed to make the CPALMS initiatives work together to truly support educators working individually and together.
