

Charter and Collegiate High Schools in The Florida College System

Background

Charter schools in The Florida College System (FCS) are statutorily authorized when an institution, in cooperation with the school board within the colleges' service areas, develops a charter school that offers secondary education and allows students to obtain an associate's degree upon graduation from high school. Since 1996, Florida public charter schools have provided smaller class sizes, alternative curriculums, and increased opportunities for parental involvement. Additionally, Florida has a number of collegiate high schools, which are innovative schools designed to provide academic and technical education for high school students interested in embarking in college-level study. The state of Florida has a series of definitions for the types of collegiate and charter high schools.

Charter School — Per section (s.) 1002.33, Florida Statute (F.S.), charter schools shall be part of the state's program of public education. A charter school may be formed by creating a new school or converting an existing public school to charter status. A public school may not use the term charter in its name unless it has been approved under this section.

Charter-Technical Career Center — Per s. 1002.34, F.S., charter-technical career centers can assist in promoting advances and innovations in workforce preparation and economic development. A charter-technical career center may provide a learning environment that better serves the needs of a specific population group or a group of occupations. Therefore, the creation of such centers is authorized as part of the state's program of public education. A charter-technical career center may be formed by creating a new school or converting an existing school district or college program to charter technical status.

Collegiate High School (not chartered) — Any collegiate high school that does not fall under the charter school category.

Career Tech Prep Academy (not chartered) — Any career tech prep academy that does not fall under the charter-tech career center category.

Dual Enrollment/Early Admission — Per s. 1007.271(7), F.S., early admission is when a high school student is enrolled full-time in college courses that lead to a certificate, associate, or baccalaureate degree. Some early admission programs may be structured so that eligible students are able to complete high school and associate degree requirements at the same time.



Survey Results

In Fall 2010, the Division of Florida Colleges surveyed the 28 colleges to update information about charter and collegiate high schools in the FCS. Of the 28 colleges, 25 responded which represents a response rate of 89%. Thirteen of those colleges reported having a charter/collegiate high school (see Exhibit 1). It should be noted that all colleges, even those without a charter or collegiate high school, offer dual enrollment options to their local service areas.
