

Request for Proposal (RFP) Measurable Objectives and Assessments

Florida's 21st CCLC objectives for the fall into two categories: **Statewide Standard Objectives** and **Applicant-Specified Objectives**. Statewide standard objectives are **required** for student academic objectives. For these objectives and corresponding assessments, standard language is provided and required for all applicants. For statewide standard objectives, applicants specify and provide a rationale for their proposed benchmarks and methods of data collection. Applicants may also specify additional academic objectives and assessments, if desired, per their evaluation plan. For applicant-specified objectives, all of the objective and assessment information must be specified by the applicant along with the plan for performance assessment and data collection.

Please note that each objective can have multiple assessments to measure student and/or adult family member progress during the school year. Remember that all objectives (student-focused and adult family member-focused) must be **performance-based**.

The chart below briefly summarizes the objective requirements for student and adult family member performance objectives according to grade levels served.

- Some information is provided for the applicant based on responses to other items in the objective assessment plan. This automatically generated information can only be adjusted by changing responses to the corresponding items.
- The number and type of objectives varies according to grade levels proposed to serve (see table above).

Statewide Standard Objectives

Applicants are required to have at least one assessment per academic objective in the domains of English/Language Arts, Mathematics, and Science according to the standard language and methods. Academic report card grades are used as the measure for assessing performance on student academic objectives. Applicants are responsible for supplying the **Benchmark, Justification of the Benchmark, Person(s) Responsible for Data Collection, and Plan for Obtaining Data.**

Applicants will select the Academic Benchmark objective(s) that aligns with the grade levels served (see table below for academic benchmark domains). Applicants are responsible for supplying the **Benchmark, Justification of the Benchmark, Person(s) Responsible for Data Collection, and Plan for Obtaining Data.**

For each of the statewide standard objectives, applicants must minimally specify and provide a rationale for each of the following:

- **Benchmark for Each Measure:** the established percent of participants that are expected to meet the standard of success.
- **Justification of the Benchmark for Each Measure:** the rationale for determining the benchmark percentage. Effective benchmarks are challenging yet attainable and data driven (informed by existing data when available).
- **Person(s) Responsible for Data Collection:** the person(s) (specify role/title) responsible ensuring that appropriate data is collected for the objective based on measurement tool used
- **Plan for Obtaining Data for Each Measure:** plan for when and how the data will be collected and how data will be transmitted.

Applicant-Specified Objectives

Applicants must specify the details of their proposed objective assessment plans for Social-Emotional Learning, Personal Enrichment, Dropout Prevention & College/Career Readiness, and Adult Family Member Services objectives.

Social-Emotional Learning (SEL) Domains: *Self-Awareness; Self-Management; Social Awareness; Relationship Skills; Responsible Decision-Making*

Personal Enrichment Domains: *Arts & Culture; Behavior & Problem-Solving; Health & Nutrition*

Dropout Prevention & College/Career Readiness Domains: *College & Career Readiness; Dropout Prevention; Entrepreneurship*

Adult Family Member Services Domains: *Family Literacy; Parental Involvement*

For each of the applicant-specified objectives, applicants must minimally specify and provide a rationale for each of the following:

- **Domain Area:** objective domain (subject area) to be assessed.
- **Grade Group(s) Served:** grade groups (Elementary, Middle, and/or High School) of students served by the program.
- **Student Grade Levels for Each Measure:** student grade levels to be assessed within each measure. Objective assessment data must be collected for all participating students throughout the program year. Applicants must ensure sufficient measures to assess the objective for all grade levels served as required per domain area.
- **Benchmark for Each Measure:** the established percent of participants that are expected to meet the standard of success.
- **Justification of the Benchmark for Each Measure:** the rationale for determining the benchmark percentage. Effective benchmarks are challenging yet attainable and data driven (informed by existing data when available).
- **Content Area for Each Measure:** main student or adult family member performance area targeted (e.g., cultural awareness, classroom behaviors, grade promotion, healthy eating, and family literacy).
- **Intended Program Impact for Each Measure:** direction or kind of change expected (e.g., improve, increase, decrease).
- **Measure Category:** type of data collection tool or instrument proposed for examining progress toward and achievement of the objective.
- **Name of the Measure:** name of the data collection tools or instruments proposed for examining progress toward and achievement of the objective. If the specific measure is unknown at the time of the application, describe and provide a rationale for the type of measure that will be selected. At least one quantitative measure must be used to assess each objective. This quantitative measure must allow for reporting of baseline data, progress toward meeting each objective during the program year, and performance on each objective at the end of the year.
- **Plan for Mid-Year Progress for Each Measure:** method for how quantitative change or progress will be assessed during the year allowing for mid-year reporting.
- **Plan for End-of-Year Performance for Each Measure:** method for how quantitative change in performance will be assessed at the end of the year.
- **Plan for Obtaining Data for Each Measure:** plan for when and how the data will be collected and who will provide and collect the data.

Additional Objectives

Applicants may specify additional objectives and assessments beyond those minimally required. Applicants must specify details of their proposed objective assessment plans for any additional academic, social-emotional learning, personal enrichment, dropout prevention and college/career readiness, and adult family member services objectives they wish to include (in addition to the minimally required statewide standard and applicant-specified objectives and assessments – such additional objectives are allowable but not required).

Examples of assessments that may be specified in addition to the required assessments include but are not limited to:

- Assessments based on end of year measures for which no quantitative mid-year progress assessment would be appropriate or available.
- Additional academic objective assessments using progress monitoring tools.
- Assessments pertaining to subgroups of students (other than grade groups) that receive programming beyond that provided to all participating students (e.g., services tailored to English Language Learners or smaller groups of students receiving a specialized needs-based intervention).

Please note that if awarded, these additional objectives become a part of the required objectives for the program.
