<b>Element Name:</b> Dropout Prevention/Juvenile Justice Placement Reasons																																																																	
<b>Definition/Domain</b>																																																																	
<p>A set of codes which indicate the allowable reasons for the student's placement in <b>each</b> Dropout Prevention program at <b>each</b> school. Codes consist of one character fields which may occur a maximum of five times. At least one placement reason code is required.
