I	<b><u>Fee Exempt:</u></b> The student is <b>a dependent of a deceased or disabled veteran</b> pursuant to Section 295.01 through 295.05, F.S.
J	<b><u>Fee Waiver:</u></b> The student is <b>a dependent of a deceased special risk member</b> (Sections 112.19(3) F.S., and 112.191(3), F.S.)
