Course Enrollment Reporting

Students must be reported in each survey in which the student is enrolled in the CAPE Innovation Course, including the final reporting survey for the year. For the 2014-15 pilot year for the AP Microeconomics Innovation Course (#2102365), the student enrollment is reported on the Student Course Schedule format for Surveys 3 and 5. The standard AP Microeconomics course number cannot be used for CAPE Innovation Course reporting.

Performance Outcome Reporting

Performance outcomes for students enrolled in CAPE Innovation Courses must be reported for all students enrolled in the course on the Industry Certification Format in Survey 5. Directions on reporting guidance for CAPE Innovation Courses are included in the following data element summaries:

The course number reported is the assigned CAPE Innovation Course number and the industry certification identifier is CAPEI001. This industry certification identifier is to be used for all CAPE Innovation Course performance reporting.

Questions and Answers Related to Data Reporting Requirements for CAPE Innovation Courses

Are districts who are offering CAPE Innovation Courses required to report students in a specific course number?

Yes. For 2014-15, a new course number has been created for the one course available. Students who are enrolled in the CAPE Innovation Course should be reported with course number 2102365 (Advanced Placement Microeconomics Innovation) in Surveys 3 and 5.

How do districts report performance outcomes that will result in funding in the 2015-16 FEFP calculation for students who complete the performance expectations in 2014-15 for a CAPE Innovation Course?

Students enrolled in CAPE Innovation Courses that meet the academic and career performance expectations may generate the additional FTE of 0.3 in the 2015-16 FEFP.¹ On the data reporting format, the code that will be used by the Department to generate this funding is value "P" on the "Industry Certification Outcome" data element.²

Each district has local systems that are used for the collection and reporting on state formats. Schools should work with their district management information system (MIS) staff on local data reporting requirements.
