Definitions

Secondary Level

Investor –

A secondary student who has earned 3 or more credits in a single career and technical education program or who had earned 2 credits in an approved 2 credit sequence program.

Concentrator –

A secondary student who has earned 3 or more credits in a single career and technical education program or who had earned 2 credits in an approved 2 credit sequence program.

Postsecondary

Concentrator

A postsecondary student who completes one-third of the academic and/or technical hours in a career and technical education program that terminates in the award of an industry recognized credential, certificate or degree.
