SUBJECT: 2020-2021 Integrated Postsecondary Data System (IPEDS) Graduation Rate Survey – Two Year Institution Exclusions

DUE DATE: Friday, November 13, 2020

The Bureau of Community College and Technical Center Management Information Systems (CCTCMIS) announces the collection of exclusions data for the *2020-2021 IPEDS Graduation Rate Survey*. This survey includes a three-year look at completions and graduation rates.

For the exclusions data collection, which begins on Friday, October 9, 2020, colleges will provide a file containing deceased students from the Fall 2017-18 cohort. The format and instructions for the exclusions file are attached.

Please submit the exclusions file with the deceased students' identification numbers using the filename CCxx.STU.EXCLUDE2.T2B2018.PROD.txt (where xx is the institution number). If your college has no deceased students in the cohort, only submit the certification form and indicate "No" on the form.

The exclusions file data submission is due Friday, November 13, 2020. The certification form is available on the [CCTCMIS website](#) and must be submitted by Monday, November 16, 2020, using the specified certification file name listed within the form.

Instructions for Deceased Exclusions File Submission

Instructions provided below.

Two Year Cohort

The Fall 2017-18 cohort file, CCxx.STU.EF2IPFIL.T2B2018 (where xx is the institution number), has been sent to your college via TIBCO by the Bureau of PK-20 Education Reporting and Accessibility (PERA). Download the file to a secure area.

Select records where:

Line = 1 Full-Time\First-Time Degree\Certificate Seeking and
Gender not equal to 'X' (unknown gender is not reported to IPEDS)

Deceased Exclusions

Include **ONLY** those records of students from the Fall 2017-18 cohort who are deceased. Include all deceased exclusions from Fall 2017-18 through, and including, Summer 2020-21.

Return the deceased exclusions file to CCTCMIS with the student identification numbers of the deceased students, if any, using the following file naming convention:

CCxx.STU.EXCLUDE2.T2B2018.PROD.txt (where xx is the institution number)

***NOTE:** Files with invalid filenames will be rejected and deleted.*

If your college has no deceased students in this cohort, please send the certification form only and indicate "No" on the form.

The deceased exclusions files are due by Friday, November 13, 2020, and the completed certification form is due by Monday, November 16, 2020.

Records not in the original cohort will not be loaded.
