The Bureau of Community College and Technical Center Management Information Systems (CCTCMIS) announces the collection of exclusions data for the 2020-2021 IPEDS Outcome Measures Survey (OM). This survey includes an eight-year look at completions and graduation rates.

For the exclusions data collection, which begins on Friday, October 9, 2020, colleges will provide a file containing deceased student data from the Fall 2012-13 cohort. The format and instructions for the exclusions file are attached.

The exclusions file data submission is due Friday, November 13, 2020. The certification form is available on the CCTCMIS website and must be submitted by Monday, November 16, 2020, using the specified certification file name listed within the form.

Instructions provided below.

Eight Year Cohort

The Fall 2012-13 cohort file, CCxx.IPEDS.OM.2013.txt (where xx is the institution number), will be sent to your college via TIBCO by the Bureau of PK-20 Education Reporting and Accessibility (PERA). Download the file to a secure area.

Eight Year Exclusions

Include **ONLY** those records of students from the 2012-13 cohort who are deceased. Include all deceased exclusions from Fall 2012-13 through and including Summer 2020-21 (eight year).

Return the deceased exclusions file to CCTCMIS with the student identification numbers of the deceased students, if any, using the following file naming convention:

CCxx.STU.EXCLUDE8.TT2013.PROD.txt (where xx is your institution number)

NOTE: Files with invalid filenames will be rejected by the server and deleted.

If your college has no deceased students in the cohort, send only the certification form and indicate "No" on the form.

The deceased exclusions files are due by Friday, November 13, 2020, and the completed certification form is due by Monday, November 16, 2020.

Records not in the original cohort will not be loaded.
