In the chapter about muscles, this textbook does do a great job of not bogging down in minute details of muscle contractions which is probably not necessary for a learner to know at this level. The book does do a great job of honing in on the important areas to emphasize with many details in a way that is not too overwhelming for a less proficient student.
