- Final date for districts to confirm ESE center schools for accountability purposes.

Summer 2020

- Memorandum sent regarding the appeals process for the 2018-19 school grades, school improvement ratings and district grades.
- Appeals process for 2019-20 school grades, school improvement ratings, and districts grades closes 30 days after the release of the INDV files.
