The use of framing questions at the beginning of each module is really effective, as well as the specific attention to "Why does this matter today". I will note though that some of the rationales for why a particular topic matters are stronger than others - I will address this more below

5. B. The level (complexity or difficulty) of the treatment of content matches the standards.

On the whole there is good alignment, but there are some places where material is over-simplified to the point where standards are potentially compromised. For example, the discussion of nationalism effectively defines nationalism by what nationalists thought it was not how historians have evaluated and analyzed it.

There is good alignment with grade level, and because of the incorporation of multimedia materials, different learning styles are catered for appropriately.

While the coverage is extremely broad, attention has clearly been paid to ensuring that the material can fit into allocated time slots.

Absolutely; I was especially impressed with how well-chosen the primary sources were.

I think the sources included are definitely very valuable, however, I was concerned at how brief the excerpts from the primary sources were. Students are being asked to answer analytical questions in some cases based on two sentences. Obviously, primary sources often involve challenging language and students at this grade level should not be expected to read whole sources, but I would urge some consideration of whether certain texts could be expanded.

D. Accuracy of Content 10. D. The content is presented accurately. (Material should be devoid of typographical or visual errors).

I did not detect any typographical or visual errors.

The material was mostly objective, although there were places were bias crept in. I saw this especially in module 14 in the discussion of labor movements and anarchism. The only thing students learn about anarchists is that "they went too far" and they are given blame for violence of which they were sometimes victims. In Module 7, there were also some hints of bias. Why is the "big idea" in the opener that civilizations in the Americas were similar to those elsewhere – sounds very pedestrian! Compare this to the "big idea" about the Renaissance which deals with the relationship between art and culture and it feels like the indigenous cultures of the Americas are

being assumed to be less sophisticated, even though the text underlines they are not. In Module 10, Lesson 4, "Opposition to Spanish Rule" the Section on Las Casas and slavery seems to suggest that Las Casas was the main person who promoted African slavery in the New World, rather than just someone who simply accepted an existing labor form. Also VERY odd this is the only mention of Las Casas – we are not told directly about his important advocacy on behalf of indigenous peoples. Mentions that he opposed tyranny, but not how. The segment also gives misleading impression that Nov 1493 St. Croix rebellion against Columbus was the only Taino armed uprising. In general, we don't get a sense of the breadth of indigenous rebellion.

Yes, mostly, although I think that there could have been more explicit engagement with what these theories, concepts, standards etc in history are - students would not gain a sense from this book of how contested and changeable historical knowledge is. Additionally, there are sometimes problems with how assignments are framed. For example, in the prologue the first analysis activity is framed as a counterfactual, asking what would have happened to democracy if the Athenians lost to Persia? Historians would not ask this type of question, instead they would ask why was Athens's victory important for spread of democracy - the same thing, just grounded in what did actually happen.

I did not notice any any outright mistakes, but there were some problematic assumptions and intepretations in places. For example, it is very controversial and potentially problematic to suggest that the Inka were proto-socialist. This idea can be engaged but I don't think it should be argued that this is the reason we need to know about the Inka.

For the most part yes, although there is very limited engagement with some of the most cutting edge research subfields such as environmental history, history of emotions, animal history etc.

Yes, there is mostly good contextualization of the material. There were one or two places where additional info was needed. E.g. Module 2 The Muslim World, Lesson 2 – Islam Expands. In table laying out differences between Sunni and Shia muslims, state that each claim the rival group have distorted the meaning of various passages in the Qu'ran, but don't explain what those passages are and what they deal with. This is confusing. It is like saying Protestants and Catholics accuse each other of misrepresenting things without describing issues around Eucharist.

F. Authenticity of Content 17. F. The content includes connections to life in a context that is meaningful to students.

This is probably the biggest weakness of the book - the connections drawn to current day life are very weak and vague, and I did not see much evidence of the "power of story" promised in the publisher pitch for the volume. The narratives were often just the traditional chronological chug through events; many students will be left bored and disconnected by parts of the book. Some specific points about framing and connections in individual chapters: The essential question for ch. 7 is confusing: "How did early American civilizations influence future societies and cultures before the arrival of Europeans" – why future? And why is "before Europeans" being used as a benchmark? There's a weird teleology throughout this whole module – we keep learning that peoples and civilizations are important only because of how they influence what comes later (which we don't yet know about...) Module 10, Lesson 6 – The Atlantic Slave Trade. The opener "Why it matters" says slavery is important because many Americans are descendants of slaves. Surely a bigger issue is that slavery was foundation of economic growth – that this incredible growth came at such a heavy human cost.

There was a definite effort to cover a range of ethnic and cultural groups and to engage gender issues. In places this was especially

notable, e.g. the discussion of women's roles in medieval Islamic societies in module 3. I would say that attention to class is a weaker point - in the discussion of the industrial revolution in ch 14, I found the effort to achieve balance by arguing that on balance the industrial revolution brought good things to people's lives to be very at odds with - and actually dismissive of - the preceding passage about how dramatically working people's life expectancy declined during the period of industrial growth and urban development.
