Jackson County Mental Health Assistance Allocation Plan 2020-2021 School Year

Delivery of Evidence-Based Mental Health Services

Tier 1

Jackson County School District focuses on delivery of evidence-based mental health services through the following Evidence Based Strategies/Curriculum/Programming:

- Social Emotional/Character Education programs are used in Kindergarten through 12th grade classrooms to emphasize and promote positive character development and prosocial behavior.
- Kagan (select schools)-Instructional practices that research has found improve academic achievement, ethnic and racial relations, social skills, social relations, and increased liking for self and school.
- Implemented Community Eligibility Provision for Free Breakfast and Lunch for all students. Research has proven that there is an association between healthy meal consumption and a student's well being physically and mentally.
- School Health Partnership with Jackson County Health Department to provide Comprehensive Health Services to all K-12 students which
 includes puberty presentations to 5th grade students, immunizations, health screenings, and health care plans for students with significant health
 concerns. Each school employs a trained health aide to administer medications, first-aid assistance, documentation of student contacts for health
 needs, and parental contacts as needed for health concerns
- The Marzano Framework for Instruction/ Evaluation is used to provide classroom environments where research based strategies are used including strategies to establish and maintain effective relationships in a student-centered classroom.
- Progress Monitoring of all K-12 students to include the following: Early Warning System (grades, discipline referrals, attendance, substantiated bullying), Administrative Walk Throughs, and Teacher Observation.
- Training for teachers/staff in the following: Suicide Prevention, Trauma Informed Care, Child Maltreatment Training, and Mental Health First Aid
- Child Safety Matters program from the Monique Barr Foundation for Children will be presented by Gulf Coast Advocacy Center staff to all K-5 students. The program will be used to increase student awareness of bullying, cyberbullying, child abuse, substance abuse prevention, child trafficking prevention, and digital dangers.
- Personal Fitness Course for 9th-12th grade students. This course is a state graduation requirement that includes state standards to address personal and family health, healthy lifestyle, responsible behavior, and how healthy behaviors improve individual health status.
- All Jackson County Schools are assigned a minimum of one school counselor per campus. School Counselors are accessible for all students who
 exhibit a need for support (grief counseling, problem solving, guidance, behavioral needs, trauma, violence, emotional support)
- Florida Positive Behavior Intervention and Supports (PBIS) utilized in 10 of our 16 schools
- Substance Abuse Prevention and Drug Awareness Presentations at all district schools during Red Ribbon Week. Too Good for Drugs instruction will be provided in Kindergarten through 5th grade district wide during Red Ribbon Week.

- Sanford Harmony Social Emotional program will be taught to all students grades PK-6th.
- Edgenuity/Purpose Prep program will be used to instruct 6th through 12th graders in the areas of : Social Emotional; Mental Health; Substance Abuse Prevention; Child Trafficking Prevention; and Character Education.

Tier 2

- Check In/Check Out interventions are provided for students that exhibit the need for interactions with staff for monitoring behavior, academics, truancy and mental status. The "Check In/Check Out" program is a Tier II intervention that is utilized to decrease behaviors that are negatively impacting student's academic and social functioning within the school environment.
- Mentoring program to provide additional social/emotional support for students in need.
- Small Group Counseling for the following: Grief/Loss; Anger management; drug/alcohol; truancy; divorce; diversity; communication; conflict resolution; anxiety; trauma; violence; executive functioning; de-escalation
- Small group counseling groups are run by: School Counselors, School Mental Health Counselors and Counselors from outside agencies.
- Progress monitoring of students through the MTSS framework to determine appropriate interventions and to implement modifications as needed to address student's social and emotional needs.
- Jackson County School District employs one full-time behavioral analyst through IDEA funds that is available to provide consultations with school professionals and direct contact services for students to improve the emotional well-being and behavioral/social skills of students.
- Teenage Parenting Program provides assistance in continuing education for eligible students, which also includes daycare assistance, medical care assistance, parenting courses and instruction in healthy lifestyle choices.
- Jackson County School District employs one full-time school psychologist that is available to provide consultations with school professionals and direct contact services for students to improve the emotional well-being and behavioral/social skills of students
- Jackson County School District collaborates with the non-profit Backpack for Kids Food Program to assist in identifying chronically hungry
 children throughout the community and provide them with food and vital resources on a regular basis.

Tier 3

- Community Action Team Services provided through referral process for students with the most severe emotional and behavioral needs that will include family and student mental health services, health care, psychiatric evaluation, medication management (if necessary), case management services, and any other additional services necessary, as determined by service providers.
- Individual therapy/counseling/screening services provided by district employed School Mental Health Counselors as funded by the Mental Health Assistance Senate Bill 7026/7030 allocation.
- Jackson County School District employs one full-time behavioral analyst through IDEA funds that is available to provide observations and
 assistance with individualized functional behavior assessments, behavioral recommendations, and behavioral intervention plans as needed with
 selected students.
- Jackson County School District employs one full-time school psychologist that evaluates students to assist in the determination of the most
 appropriate educational services to be determined by the educational team. The school psychologist also provides individual counseling services
 as needed for students, recommendations for accommodations to meet student needs, classroom strategies, and behavioral interventions.

- Referrals for counseling services will be received and then initiated by Lead School Mental Health Counselor and if necessary, referrals will be
 made to local external collaborating counseling agencies/service providers in a collaborative effort to address the mental health needs of the
 students in compliance with the requirements of the Mental Health Assistance Allocation of Senate Bill 7026/7030
- Jackson County School District employs one full-time Emotionally Behaviorally Disability Exceptional Student Education Program Specialist through IDEA funds that assists in the assessment, coordination, and delivery of on-going services for Emotionally Behaviorally Disabled students and to assist parents and school staff with effective problem-solving and assistance with exceptional student support services.
- Progress monitoring of students through the MTSS framework on a more frequent basis to determine appropriate interventions and their effectiveness and to implement modifications as needed to address student's social and emotional needs
- Threat Assessment Teams are located at each school in district and are comprised of law enforcement, counseling staff, administrative staff, and instructional staff. The teams meet to determine students that may pose a threat to the safety and security of the school environment, staff or students, and they assess and provide interventions to the identified students. The student may be referred to local collaborating counseling agencies/service providers in a collaborative effort to address the students' mental health needs, if necessary.
- Jackson County School District collaborates with Life Management Center through the referral process for students to receive services from the
 Mobile Response Team to assist the students and parents in dealing with emotional and behavioral needs that may include family and student
 mental health services, health care, psychiatric evaluation, medication management (if necessary), case management services, and any other
 additional services necessary, as determined by service providers.

Description of Supports That Address Mental Health Needs (assessment, diagnosis, treatment, and recovery)

- Upon a student self-reporting, parental report, or referral by Jackson County School District faculty or staff, individual screening services and mental health services will be provided by the district employed School Mental Health Counselors, as funded by the Mental Health Assistance Senate Bill 7026/7030 allocation, within fifteen days of the referral being received by the Lead Mental Health Counselor for the district. The screenings will be used to assess the students' mental health status and assess the present mental health needs of each referred student. If the assessment/screening reflects a need for services beyond the counseling services provided within the educational setting, a referral will be made to a local collaborating mental health agency /service provider/primary care provider in a collaborative effort to address the mental health needs of the students in compliance with the requirements of the Mental Health Assistance Allocation of Senate Bill 7026/7030. The local collaborating mental health agency/service provider/primary care provider will be responsible for insurance billing for mental health services provided to assess, diagnose, and provide treatment/recovery services to maximize 3rd party health insurance and Medicaid. The local collaborating mental health agency/service provider will initiate services within thirty days of receipt of the referral.
- Jackson County School District requires students involved in extracurricular activities to participate in random drug testing to proactively try
 to identify students that may have substance abuse issues that need to be addressed to provide interventions and mental health services, if needed.
 If a service is needed to address substance abuse services, the student is referred to a local collaborating mental health agency/service
 provider/primary care provider that is responsible for insurance billing for services provided to assess, diagnose, and provide treatment/recovery
 services to maximize 3rd party health insurance and Medicaid.

- Jackson County School District provides an alternative within the zero- tolerance policy that allows the parent/guardian and the student to request a ninety- day placement within our county alternative school in lieu of expulsion. If the parent/guardian and student make this choice, the student must participate in substance abuse counseling sessions and drug testing until he/she completes the ninety-day program requirements. The local collaborating mental health agency/service provider/primary care provider is responsible for insurance billing for services provided to assess, diagnose, and provide treatment/recovery services to maximize 3rd party health insurance and Medicaid.
- For Jackson County School District students in grades K-5, Early Warning System "watchlists" are completed by each homeroom teacher to assist in identifying students that may have mental health needs. Students in grades 6-12 have Student Support Teams that complete the Early Warning System "watchlists" to assist in identifying students that may exhibit behaviors reflective of potentially needing mental health services. The Early Warning System "watchlists" monitor for students developing social, emotional, or behavioral health problems, depression, suicidal tendencies, trauma, violence, anxiety disorders, or substance abuse disorders. If a student is identified, the student will be referred for screening to determine his/her mental health status and needs.
- All Jackson County School District staff are being trained in Youth Mental Health First Aid to assist them in detecting warning signs of social, emotional, or behavioral health problems, depression, suicidal tendencies, trauma, violence, anxiety disorders, or substance abuse disorders. If any of the warning signs are detected, the student will be referred for screening to determine his/her mental health status and needs.

Evidence-Based Mental Health Services for Students

(with one or more co-occurring mental health or substance abuse diagnoses and students at risk of such diagnoses)

• Jackson County School District will monitor the students receiving mental health services or referred for mental health or substance abuse services. The students will be monitored by reviewing attendance, academic performance, discipline referrals, and mental health service documentation to evaluate the possible need for more intensive services. If the student's mental health or substance abuse issues reflect two or more hospitalizations or he/she has failed to respond to the interventions and services provided at Tier 3, the student will be referred to the Community Action Team or Mobile Response Team for additional services.

Collaborative Partnerships with Community Providers and Agencies

- Child Safety Matters program from the Monique Barr Foundation for Children will be presented by Gulf Coast Advocacy Center staff to all K-5 students. The program will be used to increase student awareness of bullying, cyberbullying, child abuse, substance abuse prevention, child trafficking prevention, and digital dangers.
- Referrals for mental health services will be received and then initiated by the Lead School Mental Health Counselor and external referrals will
 be made to local collaborating mental health agencies/service providers/primary care providers in a collaborative effort to address the mental
 health needs of the students in compliance with the requirements of the Mental Health Assistance Allocation of Senate Bill 7026/7030, if necessary.
 The local collaborating mental health agencies/service providers that Jackson County School District has a Memorandum of Understanding

established with for collaboration of services will initiate services within thirty days of receipt of the referral, upon signed receipt of parental/student permission to share confidential and privileged information, to ensure compliance with Family Educational Rights and Privacy Act (FERPA).

- Jackson County School District collaborates with mental health agencies/service providers and primary care providers through documentation, collaborative meetings, and information sharing as needed, upon signed receipt of parental/student permission to share confidential and privileged information, to ensure compliance with Family Educational Rights and Privacy Act (FERPA).
- School Health Partnership with Jackson County Health Department to provide Comprehensive Health Services to all K-12 students which includes puberty presentations to 5th grade students, immunizations, health screenings, and health care plans for students with significant health concerns. Each school employs a trained health aide to administer medications, first-aid assistance, documentation of student contacts for health needs, and parental contacts as needed for health concerns.
- Jackson County School District provides an alternative within the zero- tolerance policy that allows the parent/guardian and the student to request a ninety- day placement within our county alternative school in lieu of expulsion. If the parent/guardian and student make this choice, the student must participate in substance abuse counseling sessions and drug testing through collaboration with local agencies until he/she completes the ninety-day program requirements.
- Jackson County School District is in partnership with Panhandle Area Educational Consortium to provide professional development for all
 Jackson County faculty and staff in the areas of Trauma Informed Care and Youth Mental Health First Aid. SEDNET within PAEC assists with
 scheduling and chairing Family Services Planning Team meetings to collaborate with all agencies and educational representatives to address all
 the present needs of the parents/guardians and the student. Risk Management within PAEC assists the district with insurance coverage, safety
 trainings, and risk assessments.
- Jackson County School District will collaborate with Florida Department of Children and Families and Big Bend Community Based Care to ensure student information is accessible and shared according to guidelines developed, the delivery of services or programs are facilitated, combining of resources is maximized for availability or delivery of services or programs to students known to DCF/BBCBC, and to avoid duplication of services or programs.
- Jackson County School District collaborates with Life Management Center through the referral process for students to receive services from the
 Mobile Response Team to assist the students and parents in dealing with emotional and behavioral needs that will include family and student
 mental health services, health care, psychiatric evaluation, medication management (if necessary), case management services, and any other
 additional services necessary, as determined by service providers.
- Jackson County School District collaborates with Big Bend Community Based Care to provide the opportunity for telehealth services for students through the usage of the Let's Talk Interactive technology at ten school sites for the 2020-21 school year. The telehealth services platform is HIPAA compliant and has the capability to expand mental health and medical services available within the schools. Big Bend Community Based Care will provide the technological resources at each school site selected. Jackson County School District will collaborate with Big Bend Community Based Care through documentation, collaborative meetings, and information sharing as needed, upon signed receipt of parental/student permission to share confidential and privileged information to ensure compliance with Family Educational Rights and Privacy Act (FERPA).
- Jackson County School District will collaborate with Pancare of Florida to provide telehealth services for students at four school sites for the 2020-21 school year. Pancare will provide a staff member and the technological resources at each school site selected. Jackson County School District will collaborate with Pancare through documentation, collaborative meetings, and information sharing as needed, upon signed receipt

of parental/student permission to share confidential and privileged information to ensure compliance with Family Educational Rights and Privacy Act (FERPA).

Process for Coordinating Mental Health Services

(with a student's primary care provider and other mental health providers, including procedures for information sharing)

- The procedures that have been developed for usage district wide is for school-based administrators/school counselors to complete the Jackson County School District internal referral for mental health services form and fax/email to the Lead School Mental Health Counselor or call immediately for assistance, if it is a crisis situation. Upon receipt of the referral form, one of the School Mental Health Counselors will be contacted to travel to the school to assess the students' mental health status and the present mental health needs of the referred student, within fifteen days of the referral being received by the Lead Mental Health Counselor for the district. If the assessment/screening reflects a need for services beyond the counseling services provided within the educational setting, a referral will be made to a local collaborating counseling agency /service provider in a collaborative effort to address the mental health needs of the student in compliance with the requirements of the Mental Health Assistance Allocation of Senate Bill 7026/7030. The local collaborating mental health agency/service provider will be responsible for insurance billing for mental health services provided to assess, diagnose, and provide treatment/recovery services to maximize 3rd party health insurance and Medicaid. The local collaborating mental health agency/service provider will initiate services within thirty days of receipt of the referral. Jackson County School District will collaborate with mental health agencies/service providers and primary care providers through documentation, collaborative meetings, and information sharing as needed, upon signed receipt of parental/student permission to share confidential and privileged information.
- Referrals for counseling services will be initiated by Lead School Mental Health Counselor and referrals will be made to local collaborating mental health agencies/service providers in a collaborative effort to address the mental health needs of the students in compliance with the requirements of the Mental Health Assistance Allocation of Senate Bill 7026/7030. The local collaborating mental health agency/service provider will initiate services within thirty days of receipt of the referral.
- Jackson County School District has developed Community of Care Collaboration forms and referral forms for usage to collaborate with primary care and mental health/service providers.

Process for identifying how many students are screened/assessed, how many students are referred for services, and how many students receive services/assistance (school-based and community).

• Jackson County School District revised the student registration form in 2018-19 to be in compliance with the Senate Bill 7026, which required student disclosure of mental health referrals when completing registration forms. When the student discloses prior mental health referrals upon registration, the school-based administrators/school counselors will complete the Jackson County School District internal referral for mental health services form and fax/email it to the Lead School Mental Health Counselor. Upon receipt of the referral form, one of the School Mental Health Counselors will be contacted to travel to the school to assess the students' mental health status and the present mental health needs of the referred student. If the assessment/screening

- reflects a need for services beyond the counseling services provided within the educational setting, a referral will be made to a local collaborating counseling agency /service provider in a collaborative effort to address the mental health needs of the student in compliance with the requirements of the Mental Health Assistance Allocation of Senate Bill 7026/7030.
- The process that has been developed for usage district wide is for school-based administrators/school counselors to complete the Jackson County School District internal referral for mental health services form and fax/email it to the Lead School Mental Health Counselor or call immediately for assistance, if it is a crisis situation. Upon receipt of the referral form, one of the School Mental Health Counselors will be contacted to travel to the school to assess the students' mental health status and the present mental health needs of the referred student. If the assessment/screening reflects a need for services beyond the counseling services provided within the educational setting, a referral will be made to a local collaborating counseling agency /service provider in a collaborative effort to address the mental health needs of the student in compliance with the requirements of the Mental Health Assistance Allocation of Senate Bill 7026/7030. The local collaborating counseling agency/service provider will be responsible for insurance billing for mental health services provided to assess, diagnose, and provide treatment/recovery services to maximize 3rd party health insurance and Medicaid. Jackson County School District will continue to collaborate with counseling agencies/service providers and primary care providers through documentation, collaborative meetings, and information sharing as needed, upon signed receipt of parental/student permission to share confidential and privileged information.
- Jackson County School District will gather data from the student registration form when parents/guardians or students indicate on the student registration form that prior mental health services have occurred. When the student discloses prior mental health referrals upon registration, the school-based administrators/school counselors will complete the Jackson County School District internal referral for mental health services form and fax/email it to the Lead School Mental Health Counselor. Upon receipt of the referral form, one of the School Mental Health Counselors will be contacted to travel to the school to assess the students' mental health status and the present mental health needs of the referred student. If the assessment/screening reflects a need for services beyond the counseling services provided within the educational setting, a referral will be made to a local collaborating counseling agency /service provider in a collaborative effort to address the mental health needs of the student in compliance with the requirements of the Mental Health Assistance Allocation of Senate Bill 7026/7030. The data for the 2018-19/2019-2020 school years of the number of students referred, screened/assessed, and that received services/assistance is compiled and assessed at the end of each school year. The students receiving services/referred for services will be tracked throughout the year by monitoring attendance, academic performance, discipline referrals, and mental health service documentation to evaluate the effectiveness of mental health services provided.

Process for identifying number and credentials of mental health services providers employed by the district.

Jackson County School District employed one Lead School Mental Health Counselor and three School Mental Health Counselors for the 2019-20 school year, as funded by the Mental Health Assistance Senate Bill 7026/7030 allocation. The decision was made to add an additional fifth counselor for the 2020-21 school year, as funded by the increase in monies provided by the Mental Health Assistance Senate Bill 7026/7030 allocation. Jackson County School District has chosen to hire a fifth School Mental Health Counselor for the 2020-21 school year, due to the increasing number of students in need of mental health services. As funded through the SB 7026/7030 allocation, once the additional fifth School Mental Health Counselor is hired, the mental health staff to student ratio for the 2020-21 school year will be 1:1,278, due to our average enrollment for the district being 6,390 total student enrollment. The Mental Health Counselor positions are required to have attained a Master's Degree in Counseling, Guidance, School Counselor, or Counseling and Psychology and currently hold or eligible to be certified by the Florida Department of Education in PK-12 Guidance and Counseling to be eligible to be

hired for the positions. The credentials of the four previously hired counselors were verified by verification of their college degrees and the Department of Education database.

Process for identifying number and credentials of mental health service providers contracted by the district.

• Jackson County School District has chosen to hire a fifth School Mental Health Counselor for the 2020-21 school year, due to the increasing number of students in need of mental health services. Jackson County School District presently employs three full time School Mental Health Counselors and one full-time Lead School Mental Health Counselor, instead of contracting with mental health providers with the allocation provided for the Mental Health Assistance Senate Bill 7026/7030. When a student is referred by their school administrator/school counselor and the assessment/screening by the School Mental Health Counselor reflects a need for services beyond the district employed School Mental Health Counselors' counseling services provided within the educational setting, a referral will be made to a local collaborating counseling agency /service provider in a collaborative effort to address the mental health needs of the student in compliance with the requirements of the Mental Health Assistance Allocation of Senate Bill 7026/7030. The local collaborating counseling agency/service provider will be responsible for insurance billing for mental health services provided to assess, diagnose, and provide treatment/recovery services to maximize 3rd party health insurance and Medicaid.

Documentation that 100% of expenditures allocated were allocated to direct mental health services or coordination of such services with primary care and mental health providers.

When a student is referred by their school administrator/school counselor and the assessment/screening by the School Mental Health Counselor reflects a need for services beyond the district employed School Mental Health Counselors' counseling services provided within the educational setting, a referral will be made to a local collaborating counseling agency /service provider in a collaborative effort to address the mental health needs of the student in compliance with the requirements of the Mental Health Assistance Allocation of Senate Bill 7026/7030. The local collaborating counseling agency/service provider will be responsible for insurance billing for mental health services provided to assess, diagnose, and provide treatment/recovery services to maximize 3rd party health insurance and Medicaid.
- Jackson County School District employs a Medicaid billing specialist for the district. The school mental health counselors hired with the Mental Health
 Assistance Allocation have been trained by the Medicaid billing specialist to complete the required documentation and filing procedures to request
 reimbursement for mental health services provided for students to maximize funding from Medicaid for services provided by district employed counselors.
