


2019-20 Statewide Funds Operations and Fixed Capital Outlay =\$90.0 billion






2019-20 General Revenue Funds Operations and Fixed Capital Outlay =\$33.9 billion








Typical Legislative Budget Cycle


Florida College System 2020-21 LBR Overview

Total proposed state funding of \$1.31 billion includes:

- □ \$40 million for Student Success Incentive Funds
- □ \$24 million for Tier Model Enhancement
- □ \$15 million for Performance Incentives for Industry Certifications
- \$16 million for Dual Enrollment Scholarship Program




The Florida College System Program Fund Appropriations by Source Lower and Upper Level Combines

The Florida College System Program Fund Appropriations per FTE Student Lower and Upper Levels Combined


