NOTES:

- 1 Adult High School, Vocational/Adult General Education Program Code 9900010, is to be used for adult students seeking an adult high school diploma. Adult students are those students who have a grade level of 30, indicating that they are no longer enrolled in K-12 courses and have not earned a high school diploma. Adult High School students must be reported with the appropriate secondary course number. Adult High School Co-Enrolled students can not be reported with a Vocational/Adult General Education Program Code of 9900010 - see note 6.
- 2 GED Prep LCPs are based on the student successfully passing the official GED tests rather than completion of the GED Prep courses.
- 3 TABE Scale Scores for ASE LOW are Reading 567-595, Math 566-594, Language 560-585; for ASE HIGH are Reading >595, Math >594, Language >585.
- 4 CASAS Scale Scores for ASE LOW are Reading GOALS 900 Series 239 – 248 and Math GOALS 900 Series 226 – 235; for ASE HIGH are Reading GOALS 900 Series 249 and above, and Math 900 GOALS Series 236 and above.
- 5 The credit in Social Studies and the 4th Credit in Science are a district level requirement.
- 6 Co-enrolled adult high school students must be reported as Adult High School Co-Enrolled, Vocational/Adult General Education Program Code 9900099. A co-enrolled student is any student who has not been withdrawn from the K-12 system, including summer students who are expected to return to the K-12 system in the Fall. Co-enrolled Adult High School students must be reported with the program code 9900099 and the appropriate secondary course number.
- 7 Beginning 2014-2015, students testing below grade equivalent 9.0 will enroll in the ABE courses (0-8.9).
- 8 Agencies that report using the separate listening and reading LCPs for ESOL and ELCATE students should not also report the general LCP values in the same term.
- 9 The unified ESL LCPs are only valid for reporting during Survey F of the 2020-21 reporting year. A separate EFL must be reported for listening and reading beginning Survey W of the 2020-21 reporting year.
- * Students can be placed into ESL Level 6 using Best Literacy but the test does not access skills beyond this level so students cannot exit ESL Level 6 with this test.
