**EXECUTIVE SUMMARY**

Pursuant to Rule 6A-1.099811, F.A.C., a school district shall enter a Turnaround Option Plan with State Board approval, as set forth in paragraph (7)(b).

This action item is for the approval of Turnaround Option Plans regarding schools in their first year of implementation during the 2022-23 school year. The submitted plans represent 30 schools in 13 districts, each of which has earned a single grade of F or two consecutive low-performing grades. These schools are in the first cycle of turnaround.

For the 2022-23 school year, the State Board of Education shall consider approval of the new Turnaround Option Plan for the districts and schools below.
