The vision of Florida's adult education system is to place learners at the center and deliver outcomes that promote full participation in the workforce, result in high-quality credentials of value and close equity and achievement gaps. The work of transforming Florida's adult education system is guided by the following strategic priorities:

Priority 1: Promote regional partnerships to ensure comprehensive approaches that result in improved learner outcomes;

Priority 2: Expand the state's talent pipeline through attainment of credentials of value and acquisition of postsecondary certifications, industry-recognized credentials and degrees;

Priority 3: Ensure all learners receive high quality instruction that prioritizes measurable labor market needs and outcomes while working to eliminate equity and achievement gaps in the community; and

Priority 4: Incent, measure and support enhanced program effectiveness.

The Florida Department of Education (FDOE) welcomes eligible applicants interested in offering innovative programming and supporting thousands of individuals both inside and outside of Florida's Workforce Innovation and Opportunity Act (WIOA) workforce system to apply.

- a volunteer literacy organization;
- a consortium or coalition of the agencies;
- an institution of higher education; organizations, institutions, libraries or a public or private nonprofit agency; authorities described above; and
- a partnership between an employer and a public housing authority; an entity described above.
