

School Year VPK Instructor Credential Options

Individuals seeking employment as a VPK instructor for the school year VPK program must meet one of the following credentials. The employer (VPK provider or prospective provider) must provide required documentation to the local early learning coalition in accordance with <u>Rule 6M-8.300, F.A.C.</u>
